#### The provision meets requirements

- The childminder recognises the importance of monitoring the quality of her service, to help her make continuous improvements. She knows how to include the views of others in her evaluations and seeks opportunities for continued professional development.
- The childminder understands how to reflect on and assess children's progress over time, to help children make sustained progress and achieve well in their learning.
- The childminder demonstrates effective knowledge of how to be a positive role model and teach children about respect and showing kindness to others around them.
- The learning environment is well organised and the childminder keeps a range of ageappropriate resources for children. She understands how to plan for children's interests and is knowledgeable about helping them to stay active and healthy.
- The childminder knows how to build effective partnerships with parents, to help ensure continuity in children's care and learning.
- The childminder understands how to ensure the environment is safe and suitable for children and to use effective procedures to minimise any potential hazards.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
