Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder does not give children enough opportunities to speak and develop their confidence and skills in expressing themselves, particularly during some adult-led activities.
- Systems for monitoring all aspects of teaching and learning are not fully effective to ensure the childminder consistently supports children's communication and language.
- At times, the childminder does not fully support children to manage their own care needs, such as cleaning their own hands.

It has the following strengths

- The childminder has a consistent approach towards managing all children's behaviour. She supports them to share, be kind, and learn about consequences to actions in a way that is appropriate to their age and stage of development.
- Children have opportunities to make friends and play with other children of a similar age. The childminder takes them to local groups.
- The childminder supports parents to help them provide their children with packed lunches that are full of nutritional value. She sensitively explains to parents why some foods may not be contributing to children's overall health.

What the setting needs to do to improve further

Inspection findings

Effectiveness of the leadership and management requires improvement

The arrangements for safeguarding are effective. The childminder has appropriate knowledge and understanding of her responsibilities to protect children against harm and neglect. She accesses training in areas, such as safeguarding and first aid. The childminder is beginning to monitor and evaluate her practice; however, she is not fully effective in identifying and addressing all areas in her teaching practice that require improvement. The childminder has established good working relationships with parents. She shares her knowledge of their children's development, such as through discussion about her assessments and in photographs. Parents are happy with the service they receive. They especially appreciate that their children enjoy being in the childminder's care and the range of creative activities they participate in.

Quality of teaching, learning and assessment requires improvement

The childminder does not give children sufficient opportunities to develop their communication and language skills, particularly during some adult-led activities, which hinders their progress. That said, she is generally aware of the children's stage of development and interests, and she uses this information to plan for their individual learning. Children make some choices for themselves. For example, they decide if they want to wear an apron to protect their own clothes while painting. Children confidently move between the rooms in the childminder's home and access a variety of resources. They enjoy caring for dolls and teddies, and building with construction bricks. The childminder helps the children begin to understand about size through introducing them to a range of mathematical language, such as small, medium and large.

Personal development, behaviour and welfare require improvement

Children are learning some skills in becoming independent, such as using a potty. The childminder supports this learning, for example, by role playing toileting with a teddy bear dressed in pants. However, she does not support some aspects of the children's self-care fully. This is because the childminder too readily does many tasks for children that they could quite easily do for themselves. Children learn about leading a healthy lifestyle. The childminder provides snacks and meals which fully contribute towards the children's ongoing good health. Children are beginning to learn how to keep themselves safe. The childminder talks to them about road safety to raise their awareness of their own personal safety.

Outcomes for children require improvement

Children are developing some skills in readiness for their future learning as they move on to pre-school and school. They learn how to sit at the table to eat. Children learn how to make relationships with others at groups they attend. They have opportunities to mark make and be creative. However, the childminder's practice is not fully effective in supporting all areas of children's learning.
