# Summary of key findings for parents

#### This provision requires improvement. It is not yet good because:

- The provider does not ensure that all relevant records required for the effective management of the club are available for inspection.
- The systems for monitoring staff performance are not effective to ensure staff receive regular coaching to support them in carrying out their roles more effectively.
- Staff do not organise the daily routines or play environment well to fully take into account the needs of all children attending, particularly the youngest children.
- Staff link well with the host school but do not engage effectively with all schools children attend. This does not support them to share information or promote a consistent approach in caring for and supporting children's individual needs.
- Self-evaluation is not used effectively to identify weaker areas of practice to ensure that staff are meeting all requirements or to identify where improvement is needed.

#### It has the following strengths

- Children demonstrate appropriate levels of confidence and independence, and they are developing suitably in their personal, social and emotional development.
- Staff are vigilant about keeping children safe. They keep accurate records of children's attendance and regularly check the numbers throughout the session.
- Staff follow suitable procedures to ensure that children are safely collected from school and escorted to the club.
- Staff have developed suitable relationships with the host school.

# What the setting needs to do to improve further

- review the organisation of the routines and some activities so that children spend less time waiting and to enable the youngest children to engage in all activities
- develop effective working relationships with other schools that children attend, to promote a cohesive approach to meeting children's overall needs well
- use self-evaluation to identify accurately all weaknesses in practice and take action to make improvements as needed to provide consistently good care and support.

- The inspector engaged in discussion with the provider at appropriate times throughout the inspection.
- The inspector talked to staff and children during the inspection.

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

There are weaknesses in the provider's organisation of the club. She is unable to demonstrate that she is meeting all requirements and this impacts on the smooth running of the club. She is unable to provide evidence that the designated lead for safeguarding and the staff preparing food have completed relevant training. The provider does not use self-evaluation systems effectively to identify areas for improvement to raise the quality of the provision. She does not target further professional development opportunities effectively to support staff to increase their knowledge and skills. However, all staff have completed the required suitability checks. They demonstrate a sufficient understanding of their roles and responsibilities to keep children safe, including what to do should they need to make a referral. Safeguarding is effective.

### Quality of teaching, learning and assessment requires improvement

Staff do not organise routines smoothly and, as a result, children sometimes spend long periods of time waiting while staff prepare activities. The activities that staff do plan offer little challenge to build on or extend the skills children already have. Children have opportunities to colour and draw using pens and paper. They play board games, take part in physical activities and engage in art and crafts. In addition, staff do not always facilitate some other activities well to enable the younger children to fully engage or take part. For example, when they take children to use the school's computer suite, they do not help the younger children to access the computers. As a result, children spend their time watching the older children, or pressing the keys with no purpose. Some children bring their own books and enjoy spending time reading.

#### Personal development, behaviour and welfare require improvement

Staff engage well with parents at collection times and they develop suitable working relationships with the host school. However, they do not liaise as effectively with other schools that children attend. Children are content, settled and are happy attending the club. They are well behaved, play cooperatively together and establish positive relationships with staff. Younger children bond well with their assigned key person. Staff are suitably deployed throughout the club to keep children safe and ensure they are appropriately supervised at all times. Children follow suitable hygiene routines and tend to their own personal needs. For instance, they are encouraged to wash their hands before eating snacks and after using the toilet and they do this independently.

Kids Space After School and Holiday Club registered in 2013. The club operates from a dedicated building on the site of St Francis De Sales RC primary school in Tottenham, in the London Borough of Haringey. There are five staff, including the provider, who work at the club. Of these, three hold relevant childcare qualifications. The club caters for children from the host school and nursery. During school term time, the club opens for a breakfast session between 7.45am and 8.45am, and the after-school session operates between 3.15pm and 6pm, Monday to Friday. The club operates during some school holidays, based on the demand.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
