# Summary of key findings for parents

## This provision is good

- The childminder observes and assesses children's progress competently. She interacts well with children and extends their learning. Children make good progress from their starting points in learning.
- The childminder creates a safe and welcoming environment. Children show a strong sense of belonging and security in the home.
- The childminder forms strong partnerships with parents. There is a good two-way exchange of relevant information that contributes to continuity in children's care and learning.
- The childminder actively encourages healthy lifestyles and personal safety. For example, she teaches children how to use knives safely when cutting up fruit at snack times. They develop a good awareness of what is good and unhealthy food.
- The childminder takes effective steps to improve her knowledge and skills. For example, she is successfully implementing what she learned at a recent training course on managing boys' behaviour. The childminder is helping boys, in particular, to express their feelings in a calm and acceptable way.

## It is not yet outstanding because:

- Sometimes the childminder does not give younger children as much opportunity as possible to explore freely and express themselves when taking part in creative activities.
- The childminder does not make the most of all opportunities to build on older children's already strong early reading skills.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- increase opportunities for younger children to freely explore, experiment and be creative
- provide further opportunities to enhance older children's early reading skills and their awareness that print carries meaning.

#### **Inspection activities**

- The inspector observed children's activities indoors.
- The inspector sampled children's learning records and other relevant documentation.
- The inspector discussed childcare practice with the childminder.
- The inspector took account of the views of parents from written feedback.
- The inspector spoke with the childminder during the inspection about the children's learning and progress, and to evaluate an activity together.

## **Inspection findings**

#### Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder keeps her knowledge of local safeguarding procedures up to date. She has a good awareness of what to do if she has a child protection concern. The childminder minimises risks to children effectively and they are able to move around freely and safely. She successfully evaluates and improves her practice to benefit children. For example, she does research and gains new ideas from other childminders. The childminder makes good use of her assessment of children to identify and narrow emerging gaps in their learning.

#### Quality of teaching, learning and assessment is good

The childminder provides a wide variety of interesting and stimulating activities for children. For example, they use their imagination well as they play with a toy farm. The childminder adds unusual items, such as a farm pond made out of cornflour, water and chocolate. Children develop good coordination, for instance, as they feel the texture of the 'pond' and make marks in it using the feet of the farm animals. The childminder builds on children's communication skills skilfully, for example, by asking questions and encouraging them to talk about what they are doing. She makes good use of stories to extend children's vocabulary. Older children join in with familiar parts of the story. Younger children act it out using the related soft toys. The childminder helps children develop a good understanding of the natural world. For example, at the inspection children confidently explained about the life cycle of a butterfly.

#### Personal development, behaviour and welfare are good

The childminder enhances children's health and well-being. For example, she provides children with healthy home-cooked meals and plenty of exercise. The childminder is kind, caring and friendly. Children form strong emotional bonds with her. The childminder has a good awareness of how to prepare children well for the move on to school. She gives children clear boundaries and helps them develop good social skills. The childminder deals calmly and sensitively with any minor disputes between children. She competently teaches them to share and take turns.

#### **Outcomes for children are good**

Children make good progress in the skills they need to help them move on to the next stage in their learning. They are confident speakers who readily engage in conversation with adults. All children develop good levels of independence. They manage their own personal care needs well. Children behave well and play happily with their friends. They are well motivated and become absorbed in their favourite activities. For example, older children spent a long time successfully completing challenging jigsaw puzzles. Younger children develop good mathematical skills, for example, when making towers and counting the blocks.
