Summary of key findings for parents

The provision meets requirements

- The manager and staff have a suitable understanding of safeguarding issues and procedures. They know what to do if they have a concern about a child's welfare.
- Staff effectively organise a wide range of activities. They understand how to adapt these effectively to include the needs of younger children when playing alongside the older children in the group.
- The manager recognises the importance of working in partnership with parents and other professionals to help provide continuity of care and learning for children.
- Staff recognise the importance of helping children to develop healthy lifestyles. For example, they plan outdoor activities each day and prepare nutritious food for snacks.
- The premises are maintained in a suitable condition for the purposes of providing an after-school club. Records are well maintained, readily available and support the safe and effective management of the setting.
- The managers have effective systems to support staff's continued learning and suitability. They evaluate the activities they provide to identify areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises, indoors and outdoors.
- The inspector made observations of the staff and their interactions with older children while involved in various activities.
- The inspector had discussions with the manager, staff and older children and looked at written feedback from parents.
- The inspector sampled documentation, including policies and records for safeguarding, staff's suitability checks, accidents and injuries and children's attendance records.

Fit for Sport at Franciscan Primary School registered in 2015 and is one of many settings operated by Fit for Sport Limited. It operates from the school premises in Tooting in the London Borough of Wandsworth. The setting provides after-school care for children aged between four and 11 years. It operates each weekday during school term time from 3.15pm to 6pm. There is a staff team of three that works with the children. Two members of staff hold relevant childcare qualifications, one at level 2 and one at level 3.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
