Summary of key findings for parents

The provision meets requirements

- The childminder maintains her knowledge through regular professional development opportunities. She understands about the work of the Local Safeguarding Children Board and updates her policies and procedures to reflect any new legislation.
- The childminder uses risk assessments to help her to review the home and garden. She provides a safe environment for children to play.
- The childminder understands about how to support children's confidence and selfesteem. The childminder plans activities, such as putting on a pantomime performance with children to show their parents.
- The childminder provides nutritious, well-balanced meals. She plans dinner time as a sociable occasion so all children get together and chat about their day at school.
- The childminder intends to help children to learn about the differences and similarities between themselves and others
- The childminder explains how she intends to encourage children to explore the outdoors and experience risk and challenge in their play.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at policies and documents the provider plans to use when caring for children.
- The inspector discussed self-evaluation with the provider and any plans for improvement.
- The inspector confirmed there was evidence that suitability checks were in place for the childminder and household members.
