Summary of key findings for parents

The provision meets requirements

- The childminder is aware of the importance of continuous improvement. She is aware of what she does well and where she can improve. The childminder has recently accessed literature to update her understanding of changes in legislation since her last inspection.
- The childminder demonstrates a secure understanding of her responsibilities in protecting children from harm and neglect. She is aware of the procedures she must follow in the event of a concern about a child in her care. The childminder risk assesses her home and ensures all potential hazards are minimised.
- The childminder understands the learning and development requirements. She describes how she observes children as they play and makes an assessment about what they know and can do. The childminder describes the range of activities she provides to support children's learning across all areas.
- The childminder describes how she shares her ideas for children's individual learning with parents in order for them to support their children's development at home.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke with the childminder throughout the inspection.
- The inspector viewed the areas of the childminder's home that are used for childminding.
- The inspector discussed with the childminder how she plans to meet the requirements of the early years foundation stage and promote children's progress.
- The inspector checked a range of documentation, including the suitability checks of adults living and working on the premises, training certificates and policies.

The childminder registered in 2009. She operates all year round from 7.30am to 6pm from Monday to Friday, except for bank holidays and family holidays.
