Summary of key findings for parents

This provision is good

- The provider is passionate about ensuring good practice and maintaining positive outcomes for children. She leads her staff team well and is encouraging of their abilities and skills. Staff demonstrate a good understanding of their roles.
- Staff implement the provider's effective policies, procedures and risk assessments to meet children's health, safety and well-being.
- Staff have a good understanding of children's individual needs. They make efficient assessment of children's starting points, which guides planning for their development. Staff use the Montessori approach effectively to complement children's learning and help them progress within expectations for their stage of development.
- Children have warm bonds with staff. All children behave very well and are respectful to their friends. They show motivation to take part in activities and understand staff expectations. Older children show awareness of each other's differences, for example, by listening as others speak and helping their friends during play activities. Children make good progress in their learning.

It is not yet outstanding because:

- Staff do not offer older children who prefer to learn outdoors enough choices to promote the different ways they explore, think actively or solve problems.
- Staff do not provide older children with enough resources that support their creativity for art and design, for example, tools, colours, materials or textures.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- extend the learning opportunities for children who enjoy and show a preference for being outdoors
- help children to be more creative to support their exploration skills and expression of art.

Inspection activities

- The inspector observed staff interacting with children during activities indoors and outdoors.
- The inspector spoke with children, parents and staff.
- The inspector completed a joint observation with the manager. They discussed how staff plan for children's learning.
- The inspector sampled the provider's documentation and children's records.
- The inspector met with the provider. They discussed how staff update their skills and knowledge, and how staff reflect on practice.

Inspection findings

Effectiveness of the leadership and management is good

The provider uses effective systems for recruitment of staff. The provider is currently recruiting, which has led to changes in staffing arrangements and the temporary use of agency staff. She is mindful of ensuring their suitability. The provider encourages staff to enhance their skills, for example, through training and acquiring professional qualifications. The provider supports staff to adapt their practice, particularly in improving their knowledge of how to adapt strategies for teaching different age groups. Staff reflect well on the provision of care. The provider regularly reviews policies and procedures, and encourages staff to share ideas, such as ways to monitor and support children's learning. Partnerships with parents are positive. Parents state they receive effective feedback from staff. They add that the nursery offers a positive experience for their children, who are developing good language and communication skills. Safeguarding is effective. Staff demonstrate a good understanding of all aspects of safeguarding matters. They know how to protect children.

Quality of teaching, learning and assessment is good

Staff know the children well and plan effectively for their learning. New systems for assessing children's attainment on entry help staff to monitor the progress children make more accurately. Overall, staff make focused observations and plan well for children's next steps. Staff are confident in their interaction skills. For example, staff working with babies plan very well for individual children, such as during activities that promote their sensory awareness. They demonstrate and show babies how to explore, for instance, with flour, make marks and encourage language by repeating words, such as 'soft'. When reading to babies, staff proactively change their tone of voice and use repetitive rhyming words to help child learn and use words, such as 'splash' and 'big'.

Personal development, behaviour and welfare are good

Staff support children's emotional well-being. Children contently make choices about what to do. Staff aid older children's awareness of healthy lifestyles. For instance, children understand the importance of washing hands prior to preparing or eating snacks or meals. They competently help clear away and wash plates and cups after eating. Staff working with younger children help guide their awareness of safety, particularly by helping them on the stairs. Younger children learn to hold the lower rail and walk down carefully. Staff conduct nappy changes sensitively and younger children sleep in accordance with their routines. Children wake contently and ready to resume their play.

Outcomes for children are good

Older children have confidence as they sound out letters and match to corresponding animal names. They demonstrate good abilities in speaking and early literacy. They develop mathematical awareness. They sort and sequence resources in size or length. Younger children have a confidence in their physical skills. They balance across a beam, throw and catch balls. All children show readiness for the next stages of their learning.

The nursery receives funding for the provision of free early education for children aged two, three and four years.
