## Information about this children's home

This home is registered to provide care and accommodation for up to four children or young people who have emotional and/or behavioural problems. The home is privately owned and run.

# This monitoring visit

This visit was carried out to investigate information received that suggests there may be a breach of regulations. No judgement was made at this visit.

The health of the young people is not fully supported by the actions of the staff. Some encouragement, via the making of appointments, is given to the young people to maintain and improve their health. However, when the young people refuse to attend health appointments this is not explored with them, and appointments are missed. In addition, recordings made by the staff to monitor the administration of prescribed medication are confusing and inconsistent.

The young people are encouraged to attend education regularly. However, the arrangements in place for some of the young people to travel to school involve a journey on public transport of up to two hours. This is due to insufficient drivers being available. The plans developed at the point of admission to the home do not fully appreciate this aspect of providing reasonable support for the young people to attend education.

There is no system in place to monitor the frequency of return home interviews following an incident of missing from home, nor is there a system to gather information that may be shared following such an interview. As a result, opportunities to better understand the risks that may face young people are missed.

Overall, the home presents as well maintained and cared for. The young people are encouraged to take responsibility for keeping their personal rooms tidy, and personalising



them to their tastes. However, some young people's rooms are not thoroughly checked by staff to ensure that good hygiene standards are maintained.

## **Statutory requirements**

ensure that staff have the experience, qualifications and skills to meet the needs of each child. (Regulation 13(1) and (2)(c))	
In particular, ensure that staff understand the importance of clear and consistent recording with regards to a child's health matters.

receive effectively planned care in or through the children's home.	
In particular, the standard in paragraph (1) requires the registered person to ensure—	
that children are admitted to the home only if their needs are within the range of needs of children for whom it is intended that the home is to provide care and accommodation, as set out in the home's statement of purpose. (Regulation $14(1)(a), (2)(a)$ )	
The education standard is that children make measurable progress towards achieving their educational potential and are helped to do so.	28/02/2018
In particular, the standard in paragraph (1) requires the registered person to ensure—	
that staff—	
help each child to achieve the child's education and training targets, as recorded in their child's relevant plans; and	
help each child to attend education or training in accordance with the expectations in the child's relevant plans. (Regulation $8(1)$ and $(2)(a)(i)(x)$ )	

#### Recommendations

- When a child returns to the home after being missing from care or away from the home without permission, the responsible local authority must provide an opportunity for the child to have an independent return home interview. Homes should take account of information provided by such interviews when assessing risks and putting arrangements in place to protect each child. ('Guide to the children's homes regulations including the quality standards', page 45, paragraph 9.30)
- Staff should seek to meet the child's basic needs in the way a good parent would, recognising that many children in residential care have experienced environments where these needs have not been consistently met doing so is an important aspect of demonstrating that the staff care for the child and value them as an individual. ('Guide to the children's homes regulations including the quality standards', page 15, paragraph 3.7)
