Summary of key findings for parents

The provision meets requirements

- The childminder knows how to support children's learning and has suitable systems to help her monitor and assess their development. She knows how to observe children during their play, and to plan activities that support the next steps in their learning. She is aware of how to support them to gain the skills they need for their future learning.
- The childminder understands how to support good behaviour and help children to be considerate and respectful of others.
- The childminder is aware of the safeguarding and welfare requirements and keeps up to date with current legislation. She knows the procedures to follow if she has any child protection concerns.
- The childminder understands the importance of working in partnership with parents. She knows to encourage two-way communication about children's welfare and learning.
- The childminder recognises the need to evaluate her practice and develop her skills, as well as to offer support and guidance to her registered assistant.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector checked evidence of the childminder's qualifications and suitability.
- The inspector looked at policies and documents that the childminder uses.
- The inspector viewed the areas of the home available for childminding and discussed with the childminder how she plans to use the space.
- The inspector asked the childminder to discuss how she plans to meet the needs of children.

The childminder registered in 2010 and lives in south-west London. She provides care between 8am and 6pm each weekday, all year round. The childminder works with an assistant.
