## Summary of key findings for parents

#### The provision meets requirements

- The childminder has a secure understanding of safeguarding and knows how to keep children safe. She is aware of the correct reporting procedures should she have a concern about children's welfare.
- The childminder demonstrates a good understanding of how to promote children's learning and development. She knows how to observe and assess children's progress, and how to plan to help them achieve good outcomes and be ready for school.
- The childminder understands the importance of working in close partnership with parents and other professionals, to help meet children's individual needs consistently.
- The childminder knows how to teach children about equality and diversity between them and how to promote positive behaviour.
- The childminder understands the need to engage in professional development and to evaluate her practice to make ongoing improvements in her practice, to benefit children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector had a tour of the areas of the premises to be used for childminding.
- The inspector held discussions with the childminder about how she intends to meet learning and development, and safeguarding and welfare requirements when caring for children.
- The inspector held discussions with the childminder about evaluating the effectiveness of her provision.
- The inspector sampled documentation, including the childminder's qualifications, evidence of the suitability of all household members, and her policies and procedures.

The childminder registered in 2006. She lives in Cranford in the London Borough of Hounslow. The childminder offers her service from 8am to 6pm, for 50 weeks a year. She holds a relevant childcare qualification at level 3.
