Information about this children's home

The children's home is one of a number of homes operated by a private organisation. It is registered to provide care and accommodation for up to two young people who have emotional and/or behavioural difficulties.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has declined in effectiveness.

Three young people have left the home since the last inspection. In general, the young people's progress, experiences and outcomes deteriorated while they were living in this home. An increase in incidents of young people going missing from care and being involved in criminal activity placed them at greater risk. Despite the efforts of the staff, they could no longer manage the young people's safety. Consequently, these two placements ended abruptly. The home worked in partnership with local authority to ensure that another young person enjoyed a positive transition from the home with the placing authority.

The two young people currently living at the home are continuing to settle. They attend school and participate in a range of activities that they enjoy. These include snooker,

going to a gym meals out and bowling. Evidence of school attendance and achievement was unavailable at the inspection, despite the manager trying to gain this from the school staff at the time of the inspection.

Young people are registered with appropriate healthcare services. However, a young person has not yet had a statutory health assessment or any medical assessment to inform their care planning. Therefore, it is difficult to ascertain the health outcomes of this young person. An in-house therapy team is accessible, and provides guidance for the staff, although evidence of this direct therapy being delivered to young people is not available, and therefore the impact of this service cannot be measured. Furthermore, staff have not been provided with training that is specific to one young person's needs, as suggested in their placing authority care plan.

Incidents of young people going missing from care are not recorded accurately. For example, young people have been recorded as being absent from care, when clearly their whereabouts were unknown. Despite risk assessments being in place, a young person who should have been reported missing from care to the police after 20 minutes was reported at 90 minutes. That said, the staff search for the young people and work with the police to promote the safe return of young people.

Young people's behaviour is challenging and the staff work hard to implement strategies for promoting respectful relationships. However, a developing pattern of bullying behaviour has not been addressed effectively, and incidents continue. This could negatively impact on young people's safety and well-being.

The staff team remains stable. This provides the necessary consistency and predictability for young people to settle. The staff have regular training, supervisions, appraisals and team meetings to inform and develop their care practice. The staff are either suitably qualified or are working towards a qualification. There are sufficient numbers of staff with the right skills to meet the needs of the young people. Serious events are generally reported to the appropriate authorities. However, one such event was not reported to Ofsted in line with regulation. This hampers information sharing, through the network of professionals to safeguard young people.

The home has recently been refurbished, and provides a homely environment. There is space for young people to have privacy and personal time alone, away from the group. The home is located in a residential area and it is indistinguishable from other residential houses.

The registered manager is aware of the strengths and weaknesses of the home. He is currently taking action to remedy the concerns identified as a result of this inspection. However, the breaches of regulations and shortfalls in practice have contributed to the judgement of declined effectiveness.

In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
