## Summary of key findings for parents

## This provision is inadequate

- The owners do not ensure that the safeguarding lead understands how to act on any safeguarding concerns raised by staff. This has a significant impact on staff's ability to protect the safety and welfare of children.
- The manager does not ensure that she takes all reasonable steps to quickly address safety issues identified by staff. This does not protect the safety and well-being of staff or children.
- The providers do not ensure that there is an effective system in place for the supervision of the manager, deputy and staff, to encourage their professional development. Therefore, underperformance has not been identified and tackled to raise the standard of their practice and promote good outcomes for children.
- Staff do not implement consistent behaviour management strategies that support children's understanding about the consequences of their actions on others.
- Staff do not assess initial information about children's development to inform planning. In addition, they do not assess children's progress or plan to meet children's ongoing learning needs. As a result, children are not engaged in challenging activities and do not make sufficient progress in their learning.

## It has the following strengths

Children enjoy time spent outside in the fresh air each day. Older children practise and develop physical skills as they carefully walk along balancing blocks or propel wheeled toys along with their feet.

## What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

## **Inspection findings**

### Effectiveness of the leadership and management is inadequate

Arrangements for safeguarding are ineffective. The owners have failed to ensure the manager, who is the safeguarding lead, has a good enough understanding of her responsibility to act on any concerns raised by staff to protect children's welfare. In addition, she has failed to ensure that safety issues identified by staff are addressed swiftly. For example, a fault with a safety gate was reported but it was not repaired or replaced. This does not ensure that the children and staff are protected from identified risks in the nursery environment. Accident records are completed by staff, and parents are informed on the same day. Staff supervision is ineffective. The providers have failed to identify weaknesses in the manager's understanding of her role and responsibilities and of staff's practice. As a consequence, little action has been taken to tackle underperformance. This has a significant impact on children's safety and progress. Parents are provided with information about the nursery's policies and procedures. Regular newsletters also help to keep parents informed about what is going on within the nursery. The providers do not identify and address weaknesses in practice. This has a negative impact on children's learning experiences and compromises their safety.

### Quality of teaching, learning and assessment is inadequate

Staff do not work effectively in partnership with parents to assess important initial information about what children know and can do. Consequently, they are unable to identify and plan for children's learning needs from the beginning. Staff do not plan activities that meet individual children's ongoing learning needs or that provide them with sufficient challenge. Young children are easily distracted by the high levels of noise made by the toddlers sharing their base room. This does not help them to develop concentration skills and engage in learning. At times, young children wander around the room with little purpose. When the older children are taken to join others in the toddler room, they become over excited. They spend periods of time running the length of the playroom and back again without engaging in purposeful play.

#### Personal development, behaviour and welfare are inadequate

The failure to meet safeguarding and welfare requirements compromises children's well-being. Information about children's personal care requirements is sought from parents. This helps the staff to deliver some effective care. Children are allocated a key person who provides parents with daily feedback about their day. Children have formed relationships with their key persons and other staff. This helps towards meeting some of their ongoing emotional needs. The manager does not ensure that suitable behaviour management is implemented by staff. They do not provide children with consistent messages about acceptable behaviour that are appropriate to their level of understanding. Children are encouraged to feed themselves. They are provided with a nutritious range of meals and snacks by the nursery chef.

## **Outcomes for children are inadequate**

Children, including those who speak English as an additional language, are not supported well enough to make sufficient progress. Young children are not developing the

concentration skills needed to help them explore, discover and problem solve. At times, activity planning does not motivate older children to learn or provide them with appropriate challenge. Children are not helped to develop the important skills needed for their next stage of learning or in preparation for starting school.

Childrens Nest Nursery registered in 2016 and is one of two nurseries managed by Splash Day Nursery Limited. The owners employ eight members of childcare staff, all of whom hold appropriate early years qualifications at level 2 and above, including four staff who hold level 3 and one who holds level 5. The nursery opens from Monday to Friday all year round. Sessions are from 7.30am until 6pm. The owners provides funded early education for two-, three- and four-year-old children.
