This children's home is part of a small organisation located in the South West of England.

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged outstanding at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

Leaders and managers ensure that when children move from this home they do so in a planned and positive way. One child successfully moved into a semi-independent home. Staff continue to maintain regular contact with the child and provide support that has ensured that the child's needs have been at the centre of the care plan. Another child has moved back to live with their family. The manager has continued to support this arrangement through regular contact and visits to the family home. Both children continue to make progress and are proud of their achievements.

Leaders and managers have ensured that children coming to live in this home have a



positive experience of moving in. Children are welcomed by staff who demonstrate warmth and nurture. The children's individual needs, wishes and feelings are taken into account, helping them to feel cared for and safe.

Leaders and managers ensure that relationships between the children and the staff are based on good communication and positive interactions. Children are empowered to make the right choices. Relationships are built on mutual trust and respect. This approach to care results in a calm household where children make positive choices and can be proud of their achievements.

Children benefit from living in a home that presents as a regular family home. It does not stand out as being different from the other homes close by. This is important to the children. They said that they do not see this as their house, they see it as their home, and they really love living here.

Leaders and managers ensure that the children receive exceptional care and unconditional affection from the staff. Children benefit from regular hugs and praise. This approach supports their emotional well-being effectively and enables them to hold aspirations about their futures.

The registered individuals have not ensured that reports completed by the independent visitor have been shared by them with the appropriate agencies including Ofsted. This has not impacted on the care that children receive, but it has prevented other agencies from having regular independent information about the care provided to children.
