Summary of key findings for parents

The provision meets requirements

- The childminder and her assistant have a good understanding of safeguarding. They are aware of the procedures to follow if they have concerns about a child's welfare.
- The childminder routinely evaluates her practice in order to identify areas for improvement. She understands the value of seeking the views of parents and children and looks at ways she can implement their ideas into her practice.
- The childminder understands the importance of promoting children's health and wellbeing and teaching them how to develop healthy lifestyles. She would provide children with healthy snacks and opportunities for physical play outdoors.
- The childminder understands the benefit to children of working in partnership with parents. She explains how she gains detailed information from them to help her to identify children's staring points in learning. The childminder knows how to recognise gaps in children's development and set appropriate next steps in their learning.
- The childminder regularly attends training to help her to develop her knowledge and skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
