# Summary of key findings for parents

# This provision is inadequate

- There are breaches of the early years foundation stage and the Childcare Register which impact on children's safety and well-being.
- Staff knowledge and understanding of safeguarding and child protection procedures is weak. This compromises children's safety.
- The provider does not ensure that there is always a staff member on site who holds a current paediatric first-aid qualification. In addition, she does not risk assess school pick-up procedures to ensure that first aid can be given to children by a qualified person.
- The provider does not ensure that required documentation is available for inspection.

## It has the following strengths

- Children settle well at the club when they arrive from school. They are confident, enjoy their play and behave well.
- Key staff know children well. They provide popular activities for children based on knowledge of their current interests.

# What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

# **Inspection findings**

### Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are ineffective. Some staff have a poor understanding of safeguarding. Staff are not fully aware of current legislation, including how to identify concerns about children or families at risk from extreme views or behaviours. Some staff do not know what action to take if there are concerns about a child or an adult who is caring for children. There are occasions when there is no staff member present with a current paediatric first-aid qualification, including on school pick-ups. These weaknesses compromise the safety of children. The provider, who is also the manager, does not ensure that staff qualification certificates, including for paediatric first aid, are available for inspection. The manager reviews the effectiveness of sessions and she monitors staff interactions with children. She has worked with others to put appropriate procedures in place with regard to the security of the setting. However, the supervision and support given to staff do not effectively identify where staff need additional training. Staff work suitably in partnership with parents to provide activities that children enjoy.

### Quality of teaching, learning and assessment is good

Children choose from varied resources. Staff provide a range of favourite activities for children. For example, children like to draw and paint. They make booklets and draw pictures using different coloured and sized pens and paper. Staff encourage children to build on what they have learned at school. For example, children practise writing their names on their pictures. Children build with different types of construction toys. They enjoy working together in teams and chat happily as they play. Children feel safe and secure. For example, they confidently request help from staff or ask for additional resources if they are not immediately available.

### Personal development, behaviour and welfare are inadequate

The breaches of the requirements of the early years foundation stage and the manager's lack of understanding of her responsibilities compromise children's safety and welfare. Children understand the rules and settle quickly when they arrive from school. They play role-play games together. For example, children act out scenes and work together cooperatively. This helps to build friendly relationships. Children make choices during play and learn appropriate hygiene routines. They are learning to be independent. For example, they take care of their belongings when they arrive after school, and pour their own drinks at snack time. Children learn about healthy foods, such as different fruits. Interactions with staff are positive. For example, staff praise children's achievements, which helps to enhance their self-esteem.
