The provision meets requirements

- The childminder has a robust knowledge of child protection procedures. She knows how to identify and report any concerns she may have about a child's safety or welfare. She understands the importance of completing risk assessments to help to provide a safe environment for children.
- The childminder understands the importance of establishing effective partnerships with parents and other professionals to support continuity in care and learning for children.
- The childminder describes how she will observe, assess and plan to help children make progress from their starting points. She knows how to identify children's next steps in learning and how to plan activities to promote their ongoing progress.
- The childminder reflects on her practice to help her make improvements. She plans training and online research to develop her knowledge and skills.
- The childminder demonstrates an understanding of how to offer an inclusive service. She has a varied range of resources for indoor and outdoor use to support children's development through play. She knows how to encourage good behaviour.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
