## Summary of key findings for parents

### The provision does not meet requirements

- The childminder does not have a current paediatric first-aid certificate as required.
- The childminder understands the differing ways young children learn and develop. She has a range of toys and activities to be ready to support children's learning.
- Systems to observe, assess and monitor children's achievement are ready for the childminder to use and share progress children make in their learning with parents.
- The childminder understands how to teach children respect and tolerance. She knows how to manage children's behaviour and how to develop their independence.
- The childminder keeps up to date with current safeguarding legislation. She knows the procedures to report any welfare concerns about a child in her care.
- The childminder knows how to reflect on her practice and identify areas to improve.
- The garden is a safe place for children to play with a range of toys to encourage children to be physically active.
- The childminder knows how to form good quality partnerships with schools to help prepare children for their next stage in learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

**To meet the requirements of the early years foundation stage and the Childcare Register the provider must:**
