Summary of key findings for parents

The provision meets requirements

- The childminder understands how children learn. She describes a range of different activities that she plans to organise to help children to develop essential skills and attitudes.
- The childminder understands how to promote children's health and well-being. She plans to provide a healthy choice of meals and regular opportunities for exercise.
- The childminder understands the importance of reflecting on her practice. She shows a commitment to identifying how to plan for future improvements, to support and enhance outcomes for children.
- Safeguarding children is given high priority and she has recently completed child protection training. She knows how to promote children's safety and welfare.
- The childminder intends to teach children to respect one another and be tolerant of other's beliefs. She is aware of how to implement positive behaviour strategies.
- The childminder knows how to share information with parents to ensure continuity of care.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas of the premises used for childminding.
- The inspector reviewed the resources and talked to the childminder about how she intends to deliver the educational programmes when caring for young children.
- The inspector discussed with the childminder her knowledge of safeguarding, risk assessment and self-evaluation.
- The inspector looked at a range of documents. This included evidence of the suitability of all adults living and working on the premises.

The childminder registered in 2015 and lives in Manchester. She operates all year round from 8am to 6pm, Monday to Friday, except for bank holidays and family holidays. The childminder holds a childcare qualification at level 3.
