# Summary of key findings for parents

#### This provision is inadequate

- The provider and his staff do not implement consistent behaviour management strategies to support children's understanding about the consequences of their actions on others.
- The provider's practices do not demonstrate that he has a secure understanding of the requirements of the early years foundation stage for out-of-school provision.
- The provider does not ensure that there is an effective system in place for the supervision of staff. Underperformance has not been identified and tackled to raise the standard of their practice.
- The provider does not ensure that the areas used by children are warm enough. During the inspection, the staff present wore their coats while working indoors and, at times, children who were not engaged in physical play huddled up together in a carpeted area.
- Children are not provided with daily opportunities to spend time outdoors.
- Staff do not effectively share information with parents to help them provide activities that reflect children's interests.

#### It has the following strengths

Children enjoy a balanced range of snacks. For example, they help themselves to fresh carrot, cucumber and a ham roll.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The provider has a poor understanding of his role and responsibilities and has not identified significant weaknesses in the quality of the provision. The limited range of activities, and poor interaction of staff, impacts on children's enjoyment and behaviour. Safeguarding is not effective. Staff do not manage behaviour well enough to ensure children's safety and do not maintain the premises at a suitable temperature. The provider and his staff understand the signs of abuse and know what to do if they have concerns about the welfare of a child. Staff recruitment is robust. Vetting procedures implemented by the provider ensure that all adults working with children have been deemed suitable to do so. Children's hours of attendance are recorded each day. This helps to ensure that the provider can account for those present in the event of an emergency.

### Quality of teaching, learning and assessment is inadequate

Children are not able to choose from a wide range of activities. For example, they argue over the limited amount dough provided and spend a lot of time wandering around with little purpose. Staff do not routinely support children's interests and preferences. Those who enjoy creative activities are given felt pens that do not work and pencils that need sharpening. This prevents them from being able to develop and extend their ideas and pursue their interests. Older children shout and scream at each other, creating extremely high levels of noise. Younger children are easily distracted by this, which does not help them to develop concentration skills and engage in play. They copy this behaviour as they shout and scream at each other and staff, in order to be heard.

#### Personal development, behaviour and welfare are inadequate

Behaviour management strategies are not implemented by the provider. Therefore, children's poor behaviour often goes unchallenged. Staff do not notice when children become over excited and accidently cause younger children to fall over and injure themselves. This demonstrates that older children's behaviour has an adverse impact on younger children. Children form bonds with their key person, which helps to meet some of their emotional needs. During the winter months children are not provided with daily opportunities to spend time outdoors. This does not help to support their ongoing good health and well-being.

Sherpa Kids registered in 2017. The out-of-school care setting employs four members of staff, including the provider. Of these, two hold appropriate early years qualifications at level 3. The setting opens Monday to Friday and some school holidays. Sessions are from 3.15pm until 6pm during term time and from 7.45am until 6pm during school holidays.
