Annual performance assessment of services for children and young people in St Helens Metropolitan Borough Council 2008

This letter summarises the findings of the 2008 annual performance assessment (APA) for your council. The evaluations and judgements in the letter draw on a range of data and information which covers the period 1 April 2007 to 31 March 2008. As you know, the APA is not based on an inspection of your services and, therefore, can only provide a snapshot based on the evidence considered. As such, I am grateful to you for assuring the quality of the data provided.

Performance is judged on a four point scale as detailed in the handbook. I should emphasise that the grades awarded are based on an overall 'best fit' model. For instance, an outstanding judgement of Grade 4 reflects that overall most aspects, but not necessarily all, of the services in the area are working very well. We know that one of the features of outstanding provision is the drive for greater improvement and no council would suggest, and nor would Ofsted, that a judgement of outstanding indicates that everything is perfect. Similarly within a judgement of inadequate overall, Grade 1, there could be some aspects of the overall service that are adequate or even good. Judgements are made in a rounded way, balancing all of the evidence and giving due consideration to outcomes, local and national contexts, priorities and decision-making.

Overall effectiveness of children's services

Grade 3

St Helens Metropolitan Borough Council continues to deliver consistently good services which result in good and improving outcomes for children and young people. It is notably improving services and outcomes for looked after children and young people. The recent joint area review report published in May 2008 judged the council's services for safeguarding, looked after children, children and young people with learning difficulties and/or disabilities and service management to be good. It judged the council's capacity to improve to be outstanding. Since then there has been no apparent down-turn in performance and further improvements are evident particularly the reducing numbers of young people not in employment, education or training.

The council has made good progress in responding to the recommendations made in the 2007 APA. Transition planning for young people with learning difficulties and/or disabilities has improved. The level of absence from school of looked after children and young people has fallen significantly over time and is now much better than that found in similar areas and the proportion of young people not in employment, education or training has also reduced. The high numbers of looked after children and young people and the increasing number of first time entrants to the youth justice system are both being tackled but remain as areas for development.

Children and young people's services have an outstanding capacity to improve further. The roles and responsibilities of officers are clear and leadership is strong. Partnerships with other services and agencies, including joint commissioning, are making very positive contributions in helping the council build further on its good performance. The council's ambitions for children and young people are prominent in many areas of its work and well determined priorities are being realised through effective strategic and operational plans. The council's analysis of its strengths and areas for development is consistent with the evidence.

The children's services grade is the performance rating for the purpose of section 138 of the Education and Inspections Act 2006. It will also provide the score for the children and young people service block in the comprehensive performance assessment to be published by the Audit Commission.

We are grateful for the information you provided as part of this process and for the time given by you and your colleagues in preparing for the assessment.
