Summary of key findings for parents

The provision meets requirements

- The childminder understands the reporting procedures to follow should she have concerns that a child is being harmed.
- The childminder intends to conduct risk assessments to minimise potential hazards and she has completed first-aid training.
- The childminder has a variety of toys and equipment available. She knows how to observe and assess children's learning and to monitor their progress.
- The childminder understands how to promote children's physical development and describes how she will organise regular trips to the park for fresh air and exercise.
- The childminder knows to establish partnerships with parents to benefit children's care and education. She will inform parents of their children's behaviour and emotional well-being.
- The childminder intends to evaluate the quality of the provision to identify strengths and areas for further development. This includes supporting her ongoing professional development and seeking guidance from other professionals.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas of the home, inside and outdoors, to be used for the care of children and discussed equipment and toys that are available to be used for childminding.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector looked at policies and documents the childminder will use when caring for children and discussed how the childminder reviews her provision.
- The inspector checked evidence of the childminder's training, including her first-aid certificate, and of the suitability of all adults in the household.

The childminder registered in 2004 and lives in the London Borough of Kensington and Chelsea. The childminder offers her service from 8am to 6pm all year round, except bank holidays. She holds a relevant early years qualification at level 3.
