Summary of key findings for parents

The provision meets requirements

- The childminder understands her responsibility to keep children safe from harm. She knows how to identify risks to children's welfare. She knows the procedures she must follow to ensure she reports her concerns quickly and to the appropriate professionals.
- The childminder understands the importance of working in partnership with parents and regularly sharing information with parents about their children's progress.
- The childminder intends to observe children as they play and complete ongoing assessments of their development in all areas of learning. She aims to use this information to plan tailored learning opportunities for children.
- The childminder keeps her knowledge up to date and identifies training to broaden her skills. She researches new developments in childcare practice. She would seek parents' comments when evaluating her provision and reflects on areas she would like to improve.
- The childminder intends to offer an inclusive service taking account of children's different ages and abilities. She understands how to manage children's behaviour and has appropriate strategies to help them to learn how to value and respect others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observations, assessments and planning.
- The inspector discussed the policies and procedures with the childminder and viewed documentation that she will use when caring for children.
- The inspector had a tour of the areas of the premises used by children and discussed the equipment and toys that are available with the childminder.
- The inspector discussed the safeguarding and welfare requirements with the childminder and took into consideration the suitability checks.

The childminder registered in 2016 and lives in Papworth Everade, Cambridgeshire. She operates all year round from 7.30am to 6pm, Monday to Friday, except for bank holidays and family holidays.
