### Summary of key findings for parents

#### The provision does not meet requirements

- The provider has failed to address the actions raised at a prior visit, to safeguard children. These breaches to requirements, including those for the Childcare Register, significantly affect children's safety and welfare. The provider does not ensure that there is always someone present with a paediatric first-aid qualification, as required, to manage any accidents.
- The provider does not follow robust vetting procedures to protect children. She does not keep relevant evidence to show staff suitability, or gain the number of the Disclosure and Barring Service check, or the date the disclosure was obtained and who checked it.
- The provider has failed to ensure that practitioners are aware of who the designated person is for safeguarding within the setting, to enable them to report their concerns promptly.
- Practitioners liaise with the teachers at the local schools, to enable the children to receive experiences that build on their learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

We will issue a Welfare Requirements Notice requiring the provider to:

Broodspring registered in 2012 in Hatfield. The club employs three childcare practitioners. Of these, two hold appropriate early years qualifications at level 3 and one holds a level 2. The club opens Monday to Friday during term time, from 7am to 9am and from 3pm to 6pm. They operate during the summer school holiday to meet the needs of the parents, opening 7am to 6pm.
