## Summary of key findings for parents

#### The provision meets requirements

- The childminder knows the procedures to follow should she have concerns about a child's safety. She keeps up to date with changes in safeguarding procedures.
- The childminder understands the learning and development requirements of the early years foundation stage. The childminder knows how to monitor and assess children's learning to support children to make progress.
- The childminder recognises the importance of working closely with parents and other settings that children attend. She describes how she shares information with others, which helps to ensure a consistent approach when supporting children's needs.
- The childminder realises the importance of updating her skills and training, and is aware of how to evaluate her practice to help to develop her service.
- The childminder recognises how to promote children's health. For example, she knows the benefits of children having daily opportunities for physical exercise and effective hygiene practices as part of the daily routine to meet children's needs.
- The childminder understands how to help children behave well and value each other.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector looked around the areas of the childminder's home used for childminding.
- The inspector discussed the childminder's process for self-evaluation and her areas identified for improving practice.
- The inspector discussed with the childminder how she intends to observe and plan for children's learning. She discussed how the childminder would work with parents to promote their children's development and progression.
- The inspector held discussions with the childminder on how she intends to meet the requirements of the early years foundation stage.
- The inspector checked registration and insurance documents, and the childminder's paediatric first-aid and childcare qualification.

The childminder registered in 1996. She lives in Waterlooville, Hampshire. The childminder holds a childcare qualification at level 3. The childminder cares for children Monday to Friday. She operates from 7am to 6pm all year round, except for family holidays.
