This home was judged good at the last full inspection.

At this interim inspection the home was 'not judged'.

This home closed in November 2017, and all the staff and young people moved to a newly registered home run by the same organisation. The requirements and recommendations from the last report and any other issues noted prior to the move will be considered as part of the new home's inspection.

No young people have been admitted to the home since November. A new manager has been appointed and their application to become the registered manager is being processed by Ofsted.

The statement of purpose for the children whom the home will accommodate has also been changed and submitted to Ofsted.

The responsible individual confirmed that he is taking this opportunity to refurbish parts of the home, for example by putting in a new kitchen. He also confirmed that there is no definitive date when he will admit a young person after the closure. However, staff have been appointed and are being prepared for this change.

The organisation has kept Ofsted informed of its plans for the home during this period.

They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.
