## Summary of key findings for parents

## This provision is outstanding

- The childminder evaluates her provision extremely well and makes continuous improvements. For example, she provides activities for children, such as dancing to support children's physical development, and singing to help support their language skills. The childminder meticulously keeps up to date with safeguarding knowledge.
- The childminder interacts with children exceptionally well to promote their learning. She supports children to positively engage and be highly motivated in all that that they do. Teaching practice is highly effective and children make excellent progress in all areas of learning and development.
- Children enjoy very warm and close relationships with the childminder, who supports their needs extremely well. The childminder emphatically supports all children to take turns, share and be very respectful to each other. Children show great kindness to their peers and behave impeccably well.
- Partnerships with parents are extremely effective. For example, the childminder exchanges verbal and written information continually, to help her plan for children's specific interests and needs. Parents are delighted with the care their children receive and the excellent progress they make.
- The childminder provides opportunities for children to enjoy very healthy and nutritional meals. She enables children to really enjoy their day. For example, she plans regular outings to the zoo to help children understand the world in which they live.

# **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The childminder shows great dedication and enjoyment in working with children. Safeguarding is effective. The childminder has an excellent knowledge and understanding of child protection procedures, and the action to take if concerned for a child's welfare. The childminder is highly committed to continuous professional development and is keen to enhance her practice even further. The childminder highly values all parents' views and comments. She uses them, along with her observations and assessments of children's learning, to closely monitor and plan for children's progress. For example, she implements extremely effective strategies to support children's communication and language development.

## Quality of teaching, learning and assessment is outstanding

The childminder very skilfully uses mathematical language in play. For example, she helps children to count pasta shapes into different-sized containers. She sings nursery rhymes with the children, and action songs that support children's awareness of themselves. The childminder supports children to learn new vocabulary at every opportunity, such as when reading stories together. She praises children as they independently turn pages, repeat words in the book, and copy the sounds she makes. Children develop their writing skills very well. For example, the childminder provides large paintbrushes and chalks for children to make marks with on different surfaces. She plans very exciting outings, such as visiting a horticultural park where ancient trees grow, and they have access to a butterfly house. In addition, she provides opportunities for children to celebrate many different festivals from around the world and taste cultural cuisine.

## Personal development, behaviour and welfare are outstanding

Children very happily and confidently seek out the childminder for support and attention. They behave exceptionally well and are very strongly encouraged to be independent. For example, young children feed themselves at mealtimes and independently negotiate risk when walking and climbing. Children really enjoy building creations with blocks and then displaying them. The childminder provides very consistent and desirable behavioural expectations, and is an extremely positive role model. When out in the local community, children learn to stay safe, for example, when crossing the roads.

## Outcomes for children are outstanding

All children develop excellent skills to help them with the next stage of learning at preschool or school. Children learn to be extremely respectful of each other. Children spontaneously sing nursery rhymes and show great interest when listening to their favourite stories, which even further develops their communication and language. Children really enjoy their day as they take part in a wide variety of interesting, challenging activities and exciting outings within the local vicinity.
