Summary of key findings for parents

The provision meets requirements

- The childminder knows about current and wider safeguarding issues. She has written procedures to follow, including how to report any concerns about a child's welfare.
- The childminder describes how she intends to check the premises, and the toys and resources she plans for children to use, to minimise risks. She knows to plan activities, observe and monitor children's learning to help them to make progress.
- The childminder understands the importance of supporting children's emotional development and well-being. She plans to make her rules and expectations clear to help children to learn to behave well.
- The childminder knows to evaluate her practice and intends to work with parents and professionals, to identify strengths and areas for improvement. She plans to develop her practice and skills to keep her knowledge up to date.
- The childminder recognises the importance of supporting children's healthy lifestyles. She describes how she plans to use the outdoor area for active play and intends to provide children with a variety of homemade meals.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas of the home, inside and outdoors, to be used for the care of children, and discussed equipment and toys that are available to be used for childminding.
- The inspector discussed with the childminder how she intends to observe and monitor children's progress. She discussed with the childminder how she plans to deliver the educational programmes for children.
- The inspector looked at relevant policies and documents the childminder will use when caring for children, and discussed how the childminder reviews her provision.
- The inspector checked evidence of the childminder's training, including her first-aid certificate, and the suitability of all adults in the household.

The childminder registered in 2009 and lives in the London Borough of Harrow. The childminder offers her service from 8am to 6.30pm, all year round, except for bank holidays. She holds a relevant early years qualification at level 3.
