Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The provider has failed to inform Ofsted of changes to committee members associated with the setting.
- The manager does not always ensure that risk assessment procedures are suitable to identify potential hazards in the outdoor area.
- The manager does not ensure that key information is consistently shared with new staff when they first start.
- Arrangements for staff supervision do not yet focus strongly enough on identifying weaknesses in practice to raise the quality of teaching to the highest level.
- Group activities are not always planned effectively to ensure children are fully engaged in their learning.

It has the following strengths

- Children are happy and settled in the provision. They have formed close attachments with staff and develop positive friendships with each other. This helps to support their social and emotional development.
- Staff know their key children well. They collect good-quality information from parents when children first start, to help identify what children can already do.
- Gaps in children's learning are identified quickly and supported well by staff. They work alongside other professionals to implement strategies and support children's individual needs.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage the provider must:

- strengthen supervision arrangements to focus more strongly on raising the quality of teaching to the highest level
- review the planning of group activities to ensure children's involvement and engagement are fully promoted.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and assessed the impact this has on children's learning.
- The inspector completed a joint evaluation of an activity with the manager.
- The inspector held a number of discussions with the manager, provider and staff. She looked at relevant documentation and evidence of the suitability of staff.
- The inspector spoke to children during the inspection.
- The inspector spoke with parents during the inspection and took account of their views.

Inspection findings

Effectiveness of the leadership and management requires improvement

The provider has failed to notify Ofsted of new committee members associated with the setting. This means Ofsted has not been able to carry out required checks to ensure that the registered body is made up of individuals who are suitable to be involved in childcare. The manager follows suitable recruitment procedures and ensures new staff receive Disclosure and Barring Service checks before working directly with children. However, induction procedures are not always followed. This means that not all staff and students are fully aware of their roles and responsibilities when they first start. Safeguarding is effective. Staff display a good understanding of local authority reporting procedures and how to promote children's welfare. The manager arranges child protection training for staff and shares information about changes to guidance. Staff have opportunities to attend supervision meetings with the manager and discuss their performance. However, feedback is not always sharply focused on what staff need to do to improve their knowledge and teaching skills further.

Quality of teaching, learning and assessment is good

Staff engage well with children and promote their language skills effectively. They ask a range of questions during activities to help promote children's thinking skills and communication. For example, staff ask children to consider which key they will use to open a padlock. Generally, staff plan a good range of activities that children enjoy, such as story sessions and imaginative play. However, occasionally during larger group activities, children become distracted and less involved. Staff complete observations of children's learning and monitor their progress well. Information about children's development and activities is shared regularly with parents. Staff discuss with parents how to support children's learning at home and share resources, including books.

Personal development, behaviour and welfare require improvement

Staff are not thorough in completing suitable checks on the outdoor area before allowing children to play outside. This means that potential hazards are not always removed in a timely manner. The provider and manager have already identified the outdoor area as an area targeted for improvement. Staff use available space indoors to plan physical activities and games for children. They support children's understanding of healthy lifestyles and promote suitable hygiene procedures. Children are encouraged to be independent and make choices in their learning. Staff reinforce boundaries and use positive praise to help support children's self-esteem.

Outcomes for children are good

All children make good progress in their learning. They develop confidence and good social skills. Children display an interest in stories and have opportunities to develop their mark-making skills and recognise their names. They are encouraged to count objects during play and place numbers in the correct order. This helps to prepare children well for their next stage in learning and eventual move to school.

Manor Childcare Centre registered in 2010. The setting employs eight members of childcare staff. Of these, five have appropriate early years qualifications at level 3 and above. Two members of staff hold qualified teacher status. The setting opens Monday to Friday for 51 weeks of the year. Sessions are from 8am until 5.55pm.
