## Summary of key findings for parents

## This provision is good

- The childminder effectively supports children's communication and language. She engages them in meaningful conversations as they play and during every day routines. Children develop good speaking and listening skills.
- The childminder provides regular opportunities for children to meet others and learn about the world around them. They attend local groups that take place indoors and outdoors. Children join in with a broad range of activities and develop the skills they need in readiness for their future moves on to nursery and school.
- Children are happy and settled in the childminder's welcoming home. They develop close relationships with her and each other. The childminder is kind and caring, and attentive to children's individual needs.
- The childminder invites parents' feedback and uses this to reflect on how she can improve her practice.

#### It is not yet outstanding because:

- Children have fewer opportunities to express their own ideas and be creative during activities.
- The childminder does not use her assessments fully to help check on and enhance the progress of children's learning more closely.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- increase opportunities for children to express their own ideas and be creative
- enhance the use of assessments to help identify where children might make faster progress in their learning.

#### **Inspection activities**

- The inspector observed the quality of teaching during activities indoor and outdoor, and assessed the impact this has on children's learning.
- The inspector viewed the areas of the home used by children.
- The inspector looked at a selection of children's assessment records, the childminder's policies and procedures and a range of other documentation.
- The inspector spoke to the childminder and children at appropriate times through the inspection.
- The inspector took account of the views of parents from the written feedback provided.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder promotes children's safety well. She carries out daily checks of the environment and supervises children closely at all times. The childminder knows the procedures to follow should she have a concern about a child's welfare. She understands how to protect children and is aware of the signs that may indicate that a child is at risk of harm. The childminder is committed and professional in her approach. She keeps herself up to date through training and liaising with other childminders and support agencies. Parents share positive feedback about the childminder. For instance, they comment that their children have flourished and their speaking and confidence have improved.

### Quality of teaching, learning and assessment is good

The childminder provides a good range of learning opportunities within and outside of the home. In the main, she provides enjoyable activities that help children to develop well towards their next steps in learning. The childminder understands how children learn and develop, and interacts well with them. She sits alongside children at their level and joins in with their play. The childminder provides good support to develop children's early literacy. Children have independent access to a range of books and enjoy choosing their favourites. They listen intently as the childminder reads to them. She skilfully uses her voice and gestures to capture children's sustained attention. Using props, such as puppets, children enthusiastically join in with familiar words and phrases.

#### Personal development, behaviour and welfare are good

Children's behaviour is good. The childminder has a positive and consistent approach to managing behaviour. She praises and encourages children in their play, successfully developing their confidence and self-esteem. Children are learning to be kind and caring towards each other. They share and take turns. The childminder provides children with a range of healthy meals and snacks. She works closely with parents to ensure that any specific dietary requirements are adhered to. Children manage their own personal hygiene well. For example, they wash hands before eating and after using the toilet. They wipe their own noses and know to appropriately dispose of used tissues in the bin.

#### **Outcomes for children are good**

Children enjoy their learning and are eager to join in with activities and games. They progress well with their physical skills. Children develop their small-muscle skills as they practise using scissors to cut pictures out of magazines. Outdoors they show how they can jump on the trampoline and understand the rules of safe play. Children use their imaginations as they use role-play equipment and make links with their own experiences. Children gain the skills they need to prepare them well for their next stage in learning and for their eventual move on to school.
