Summary of key findings for parents

This provision is good

- The provider works alongside staff and models good practice to help raise the quality of their planning and teaching. All children make good progress from their starting points.
- The provider and staff successfully support children's emotional well-being. Staff are positive role models. They are caring, kind and attentive. Children are settled, and they play happily. They develop positive relationships with staff and other children.
- Children behave well and show consideration towards others as they share and take turns in their play.
- Partnerships with parents are strong. Staff keep parents informed about their children's good progress and suggest helpful ideas to encourage learning at home. They build links with other early years professionals to promote continuity for children's progress and well-being.

It is not yet outstanding because:

- Staff do not always use effective strategies to support the children's individual needs and encourage the best possible progress in their learning and development.
- Staff do not make the best use of the outdoor environment to fully support children who learn better outdoors.
- Staff do not provide a variety of resources and opportunities to allow children to express their own ideas and to enable them to use their imagination.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- use more effective strategies to support children's individual needs and promote the best possible progress
- make better use of the outdoor environment to support those children who prefer to learn outdoors
- provide more resources and opportunities to allow children to explore and express their ideas imaginatively.

Inspection activities

- The inspector observed the quality of teaching during activities indoors and outdoors. She assessed the impact this has on children's learning.
- The inspector spoke to staff and children during the inspection.
- The inspector completed a joint observation with the provider.
- The inspector held a meeting with the provider, who is also the manager. She looked at relevant documentation and evidence of the suitability of staff working in the nursery.
- The inspector spoke to parents during the inspection and considered their views.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The provider has thorough staff recruitment procedures in place to ensure staff are suitable to work with children. The provider and staff are vigilant about the signs that might lead them to be concerned about a child's welfare. They are clear about the correct procedures to follow to keep children safe from harm. The provider supports the professional development of her staff well through training courses and mentoring. This helps staff to learn new skills and continually improve their teaching. The provider has good systems to monitor the progress of individual and all groups of children. This helps her to identify and address gaps in their learning.

Quality of teaching, learning and assessment is good

Staff have a good understanding of how children learn through play. They use their accurate assessments of children's levels of development to plan the next steps in their learning. Children are given time to concentrate on activities and develop skills, such as when practising flower arrangements, threading, and filling and emptying resources from containers. Children are very skilful at using tweezers, spoons and various tongs. This helps to strengthen their small-muscle skills in preparation for writing. Older children show their skills in forming written letters, numbers, and letter sounds. Children enjoy creative experiences where they learn how to use scissors and develop their skills in art and craft work. Staff use mathematical language with children as they play to help them to order objects by size and colour.

Personal development, behaviour and welfare are good

Children develop excellent independence skills. They put their coats and boots on independently to go outside. Children help to tidy up, wash their hands before eating, and wash cups and plates after snack time. Parents provide nutritious meals to complement the healthy snacks provided by staff. They work together to ensure that children's individual dietary needs are met. Children develop good physical skills. They have opportunities to be physically active outdoors. Children learn to negotiate space, balance and jump off equipment safely.

Outcomes for children are good

Children are active and motivated learners who initiate their own play and follow their own interests. Children sit, listen and concentrate well. They show great confidence to speak in small and large groups. Children are eager to show what they can do and try to do new things. Children display a positive attitude as they embed the skills needed for their future learning and the eventual move on to school.

Bluebell Montessori School Limited registered in 2015. The nursery is open each weekday from 8am to 6pm, all year round, apart from during bank holidays and at Christmas. The provider employs four childcare staff. Of these, two hold a qualification at level 3 and two staff, including the provider, hold a level 4 Montessori teaching diploma. The nursery provides funded early education for two-, three- and four-year-old children. The nursery incorporates the Montessori teaching method with the early years foundation stage.
