Summary of key findings for parents

This provision is inadequate

- The management team has taken insufficient action to improve the provision since the last inspection. Some breaches of the requirements relating to the Early Years Register and Childcare Register still remain.
- The management team has a poor understanding of its safeguarding responsibility for reporting allegations against staff to the relevant authorities, including Ofsted, without delay. This compromises children's safety and places them at risk of harm.
- Risk assessment processes are weak. Managers and staff do not use outdoor equipment appropriately, in line with manufacturer's safety guidance, with particular regard to the large trampoline. This has a negative impact on ensuring children's safety.
- The provider does not supervise staff effectively to ensure that they have the skills to support children's learning well and to ensure the quality of teaching is at a consistently good level.
- Staff do not plan activities effectively to engage and challenge children fully, and to stimulate them to learn. Therefore, children do not make the best progress possible.
- Staff do not engage all parents in their children's assessments by sharing regular information about their children's progress, including how to support learning at home.

Inspection findings

Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The management team has failed to follow the procedures for reporting an allegation made against a member of staff within the required timeframe to the appropriate authorities, including Ofsted. This has a significant impact on ensuring children's welfare. In addition, they continue to lack awareness of potential risks in the environment. Despite addressing previous safety issues from the last inspection, further risks relating to the safe use of the trampoline have been identified at this inspection, which compromises children's safety. The provider and manager do not monitor staff practice or the quality of the provision effectively to ensure that staff have the knowledge or skills to carry out their roles effectively. They have given people key responsibilities and have not ensured that they are fully competent in these roles. Despite staff having regular supervision meetings with the manager to discuss training needs, this support is not well targeted and does not have the necessary impact on teaching to improve the overall quality. In addition, when undertaking a joint observation, the manager could not identify how teaching and children's learning could be improved. This demonstrates a poor capacity to improve or identify when the nursery is not meeting statutory requirements.

Quality of teaching, learning and assessment is inadequate

The quality of teaching is inconsistent. Staff do not plan activities or resources in the learning environment well to interest or motivate children; the range is limited and presents little challenge or stimuli. In addition, some staff do not engage well with children to facilitate or extend their learning effectively. For example, during two separate science activities, staff were unclear of the learning intention and, therefore, they were unable to gauge their interactions with children to support their learning. Other aspects of teaching are variable. For example, not all staff communicate well or model language with the younger children, and some miss opportunities to question children or respond to their ideas to extend or reshape their thinking. Therefore, children lack focus in their learning and, at times, are disengaged. Systems for tracking children's progress are in place. Staff identify some children's starting points on entry and check their progress throughout the year. However, staff do not always share assessment information with all parents or support them to extend their child's learning. Therefore, some parents are unaware of their children's progress and stage of development, including knowing how to continue to support their children's learning at home.

Personal development, behaviour and welfare are inadequate

The weaknesses in leadership and management significantly compromise children's safety and welfare. The failure to report allegations and follow the correct procedures has a significant impact on ensuring children's well-being. In addition, staff are unaware of the safety guidance for allowing children to use the trampoline. For instance, staff do not assess risk and manage the use of the trampoline adequately, or implement appropriate rules for children to use it. This means that children lack a clear understanding of how to keep themselves safe, particularly when using the trampoline. Staff promote children's health sufficiently. They provide healthy snacks for children and meals are prepared by outside caterers. Children have regular opportunities to engage in outdoor play although,

due to weaknesses in teaching practice, staff do not necessarily make the best use of the learning opportunities presented. Overall, staff manage unwanted aspects of children's behaviour appropriately. They provide clear explanations to children and reinforce the rules and boundaries.

Outcomes for children are inadequate

Not all children make sufficient progress and achieve the typical milestones for their age. Weaknesses in the quality of teaching limit the amount of progress children make. This hinders them from gaining all the necessary skills they need in preparation for the next stages in their learning, including for school. Older children are learning some skills in being independent. For example, they learn to serve their food and attempt to scrape their plates after meals.

Bubbly Nursery Ltd registered in 2007. It operates in Willesden, in the London Borough of Brent. The nursery is open each weekday from 8am to 6pm, for 51 weeks a year. The nursery receives funding for free early education for children aged two, three and four years. There are six members of staff, including the manager. All staff hold relevant childcare qualifications at level 2 or above, and the manager has qualified teacher status.
