## Summary of key findings for parents

#### This provision is inadequate

- The manager does not make sure that the provision meets the statutory requirements. Many of the breaches of requirements found at this inspection have been raised before by inspectors, including the need to ensure staff are suitable to work with children.
- The manager and staff do not provide care and early education that meets the needs of the individual children. This impacts negatively on children's learning and development and means that children do not make the progress they should. Children's health and welfare are not well promoted.
- Staff do not have a good enough understanding of some aspects of how to safeguard children. The manager and staff do not have the skills, knowledge and information required to fulfil their roles.
- Staff do not manage children's behaviour effectively. This means that children are not learning the difference between right and wrong and why some behaviour is not acceptable.
- The quality of teaching, including the use of observation and assessment of children's learning, continues to be poor. Children are not engaged in activities that provide sufficient challenge or stimulation.
- Risk assessment is not effective and does not ensure children's safety. For example, children have access to resources that are not suitable for their age group.

#### It has the following strengths

■ The nursery is inclusive and welcoming. Parents are happy with the care provided and find the staff friendly and caring.

- The inspector spoke to staff and children at appropriate times throughout the day.
- The inspector conducted a joint observation with the manager and held a meeting with her regarding the leadership of the setting.

## **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The manager is not able to drive the improvements required. The nursery is not meeting the statutory requirements of the early years foundation stage. Safeguarding is ineffective. Staff do not have a sound understanding of how to fulfil their duty to prevent children being drawn into situations which put them at risk of harm. The nursery's safeguarding policy is not easily accessible to the staff and does not contain all the required guidance. Furthermore, staff do not always follow the nursery's own policies to protect children. For example, staff are told by the manager to record pre-existing injuries to children and ensure that attendance registers are accurate, but this does not always happen in practice. The history of the nursery shows that some of the weaknesses identified at this inspection have been pointed out to the manager several times before. This means that any improvements made following inspections are not being sustained. For example, there are still weaknesses in the procedures for recruiting new staff to ensure they are suitable to work with children. Staff do have opportunities to meet routinely with the manager, but the supervision meetings are not leading to improvements in the quality of care and teaching practices.

#### Quality of teaching, learning and assessment is inadequate

Staff carry out frequent observations of children. However, the observations do not demonstrate a sound understanding of the way in which children learn and develop. This means that assessments of children's learning are sometimes inaccurate and not well used to help children make good progress. The activities planned are not suitably challenging for children and sometimes staff's expectations of what children can achieve are too low. The resources are not always suitable for the ages of the children. Staff are not confident teachers. Although they speak to the children throughout the day, they fail to introduce new words and concepts to the children to extend their learning. Conversations and activities are not interesting enough to engage children and spark their curiosity. Staff do not foster children's love of learning. For example, while out on a walk a child spotted a snail, but was not provided with the opportunity to explore this any further. Staff miss many opportunities to introduce number, space, shape and measure into children's play, for example, when children are pretending to shop.

#### Personal development, behaviour and welfare are inadequate

The breaches of the safeguarding and welfare requirements compromise children's safety and welfare. The routine of the day sometimes prioritises staff's needs rather than those of the children. For example, nappy changing routines do not ensure children's emotional security is supported. Children are not always handled carefully or with respect. For example, when being rocked to sleep or dressed. Children's health is not well supported as some hygiene practices are poor. For example, children briefly wet their hands prior to eating and have nothing to dry them on. This does not ensure that children's hands are clean. Whilst on an outing to the park children are allowed to pick crocuses that have been planted for the community to enjoy. Children's well-being is put at risk as dogs clearly fowl in the area. Furthermore, children are not learning to respect the local environment. The key person arrangements are not effective at meeting individual

children's needs. Staff are asked to be key persons for children, but do not have the knowledge, understanding and experience to fulfil the role. Staff do not mange children's behaviour in a consistent and positive manner. Children are frequently given instructions, but often without any explanation to support their learning.

#### **Outcomes for children are inadequate**

Weaknesses in the quality of teaching have a negative impact on the progress children make at the nursery. Most children are content and happy in the care of the staff, who do form caring relationships with them. However, often children's individual needs are not met. For example, some children, especially quieter children and babies, do not receive the care and attention they should. Children's opportunities to play and explore are limited by the narrow range of resources and activities offered. Opportunities for children to learn about healthy lifestyles and take part in physical exercise are too few. Some children are confident talkers but for those children the educational programme lacks challenge. Other children, including those with English as an additional language, are not provided with the help they need to develop essential communication skills. Therefore, children are not well-prepared for the next steps in their learning.

Strawberry Babybubs Nursery registered in 2013. The nursery is situated in Bermondsey, in the London Borough of Southwark. The nursery employs nine staff; of these, seven hold appropriate early years qualifications from level 3 to level 5. The nursery opens Monday to Friday, all year round, except for bank holidays. Sessions are from 7.30am to 6pm.
