Summary of key findings for parents

The provision meets requirements

- The childminder understands how to meet the needs of all children, including those who have or may have special educational needs and/or disabilities. For example, she has developed effective partnerships with parents and other professionals to ensure all children's developmental needs are fully met.
- The childminder regularly reflects on her practice and areas for improvement. For example, she has improved her mathematical resources to provide extra challenge. Children are now able to practise their sorting skills using toys of different shapes, colours and textures.
- The childminder has significantly improved the safety and security within her home and garden. For example, she has implemented effective procedures for when parents collect children at home time. This ensures the safety of children at all times.
- The childminder understands the importance of using observation and assessments to ensure all children make progress from their starting points. She regularly monitors children's progress to ensure they are well prepared for school. The childminder shares key information with schools to further support children's transitions.
- The childminder has completed further child protection research. This has improved her knowledge of wider safeguarding matters, including the 'Prevent' duty. The childminder is also aware of the action she should take if she has any concerns about a child's welfare.
- The childminder understands how to ensure that children show mutual respect and kindness for each other. She promotes the use of sign language, so all children, including those who have or may have special educational needs and/or disabilities can communicate with their friends.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
