# Main inspection findings

#### Part 1. Quality of education provided

### All relevant paragraphs

- The school's curriculum policy and related schemes of work, extended to account for pupils aged up to 11 years, meet requirements. Curriculum planning in all the required areas of learning is based on suitable commercial schemes of work. Teachers' weekly plans are detailed and take account of pupils' different ages and abilities.
- All teaching across the year groups and subject areas is in English.
- All classrooms are appropriately resourced and conducive to learning.
- The curriculum provides ample opportunities for pupils to learn about British values and equality.
- There is a robust system for checking pupils' progress. All pupils complete a range of assessments, including regular tests in their core skills, appropriate to their age and ability.
- Leaders have ensured that the relevant independent school standards in this part are met.

#### Part 2. Spiritual, moral, social and cultural development of pupils

#### All paragraphs

- The curriculum for pupils in Years 5 and 6 actively promotes British values and encourages respect for other people. This includes paying particular regard to the protected characteristics, including other religions. Leaders ensure that respecting others and learning about how people are different are clear focuses of the school's work.
- Leaders have ensured that the independent school standards in this part are met.

#### Part 3. Welfare, health and safety of pupils

## Paragraphs 7, 7(a), 7(b), 11, 12, 14, 16, 16(a) and 16(b)

- The school's approach to safeguarding its pupils continues to meet the requirements of the independent school standards and national statutory guidance. The school's policy and procedures are appropriate and will be published on the school's new website when it is redesigned. In the meantime, the policy is available in hard copy.
- There is a strong culture of safeguarding. Concerns are raised quickly and shared with suitably trained designated safeguarding leaders and external colleagues in social care services, as appropriate. As a result, pupils are kept as safe as possible.
- Leaders have ensured that the school's health and safety policy is effectively implemented. The premises and facilities, though temporary, are clean, safe and well maintained.
- Leaders have ensured that the school complies with the Regulatory Reform (Fire Safety) Order 2005. Evacuation drills and all the required checks are undertaken and logged meticulously.
- There is appropriate deployment of enough staff to ensure that pupils are safely supervised.
- Leaders have ensured that the school's risk assessment policy is effectively implemented. Risk assessments relating to the premises show that appropriate thought is given to reduce risks, so as to ensure that pupils are kept as safe as possible.
- Leaders have ensured that the independent school standards in this part are met.

### Part 4. Suitability of staff, supply staff, and proprietors

#### All paragraphs

- Leaders ensure that all the relevant vetting checks are undertaken on those who come into contact with pupils. All recruitment checks are recorded accurately on the school's single central register, which meets all the current requirements.
- Leaders have ensured that the independent school standards in this part are met.

#### Part 5. Premises of and accommodation at schools

#### All paragraphs

- The school's premises are temporary, but are clean, safe, secure and well maintained. There is comfortably room for up to 110 pupils aged up to 11 years old. The health, safety and welfare of pupils are likely to be assured through the effective implementation of the school's health and safety policy and procedures.
- There are eight classrooms of various sizes, including large spaces for children in the early years. There is ample outdoor space for play and physical education. There are also ample toilet and washing facilities, which meet requirements.
- The requirements in relation to medical care and first aid are met.
- The acoustic conditions, sound insulation and internal and external lighting are suitable throughout the premises.

- Suitably labelled drinking water is available throughout the school day from water coolers, and the temperature of hot water supplies is safely regulated.
- Leaders have ensured that all the independent school standards in this part are met and are likely to continue to be met if the number of pupils increases to a maximum of 110.

#### Reason for inspector's recommendations

The school's original application was to extend its age range to 3 to 11 and its maximum capacity to 95. This change has already been partially implemented, as there are currently 90 pupils on roll, aged up to 11 years old. During the inspection, the headteacher asked the inspector to consider the capacity of the premises and whether the number of pupils on the school roll could increase further. The inspector's

recommendation is that the maximum capacity of the school should be 110.

## **Information about this school**

Inspection report: Beis Yaakov Girls School, 12 March 2018



- Beis Yaakov Girls School is an independent primary day school in the London borough of Hackney. It caters for girls from an ultra-Orthodox Jewish faith.
- The school's last standard inspection took place in April 2017, when it was judged to be good and all the independent school standards were judged to be met.
- The school is currently operating outside of its registration agreement. There are currently 90 pupils on roll aged up to 11 years old.
- The school's website is currently being redesigned. In the meantime, all the required policies and information are available in hard copy to parents.



# Information about this inspection

- The inspection was commissioned by the Department for Education (DfE) to consider the school's application for a material change to its registration. The proprietor wishes to increase the number of pupils on roll and extend the age range.
- The DfE requested that the inspector consider whether particular independent school standards contained within Parts 1, 2, 3, 4, 5 and 8 are met.
- The inspector met with the headteacher and the head of secular studies. He toured the premises and reviewed a range of key documents and policies in relation to the independent school standards. He also briefly observed learning in all classrooms.
- The inspector took account of the 16 recent responses to Ofsted's online survey for parents (Parent View).
