Information about this children's home

This children's home is operated by a private organisation and is registered to provide care and accommodation for four young people. The young people may have emotional and/or behavioural difficulties.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has declined in effectiveness.

A registered manager has not been in post for over 36 weeks. The current manager has failed to submit an application for registration. Senior managers are providing her with good support and guidance.

The home environment requires improvement. Children are not provided with a comfortable, welcoming environment in which to live and thrive. Damage to the home is not repaired to a good standard. In addition, staff have failed to ensure that the home is cleaned to a good standard. This was raised with the responsible individual at the inspection. She began to take action to address this during the inspection and further work is scheduled.

All staff are provided with a fire briefing when they start to work at the home. There were two new staff who had not taken part in a fire drill or practice as required by the

Children's Homes Regulations.

Staff at the home know the children well and there is evidence of discussions at team meetings regarding the children's needs and how staff will meet these. Children's care plans are not updated to reflect agreed actions.

At the previous inspection, four requirements and two recommendations were made. Of these, one requirement remains unmet. This relates to the effectiveness of the manager's monitoring and review systems. There has been some improvement in this area, but further work is still required to make continuous improvements in the quality of care provided in the home. The quality of the notifications sent to HMCI has improved.

The records of restraints are now clear and contain all of the required information. Staff are no longer using vague or emotive language to describe children's behaviours. Children's case records are now signed and dated by the authors. This assists in the auditing of documents as well as providing evidence of children's progress.

The reports of the independent person are now being received by HMCI in a timely manner.

Children's engagement and progress in education has improved. They benefit from having individualised creative education timetables. A number of the children greatly benefit from being able to access the provider's farm as part of their education. Some children are also attending local colleges.

Safeguarding systems at the home remain strong. Policies and procedures are understood by staff and followed in practice. Comprehensive records of all safeguarding events are maintained.

Children are positive about living at the home and they like the staff who care for them.

Behaviour is appropriately managed and restraint is only used as a last resort. Since the previous inspection, there has been one restraint. The record of this is clear and contains all the required information. Staff have carried out a great deal of positive work with the children around substance misuse. This has involved some children attending sessions with external agencies. This work has raised children's understanding of the risks.

Staff manage incidents well when children go missing. This can involve a significant amount of travel. Staff liaise effectively with social workers and police with regard to missing person incidents.

Staffing levels are appropriate to meet the needs of the children living at the home. At the previous inspection, it was noted that the staff team was fairly new. Staff appear to have bonded well as a team. The manager uses some sessional staff, who are employed by the provider, to cover any staffing shortfalls. Although these staff are not part of the home's core team, they have worked for the provider for a number of years. There have been two new members of staff recruited who are just about to commence working at the home. Since the previous inspection, the provider has recruited an enhanced therapeutic senior practitioner. This person is providing additional support for the children and the staff team.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
