Summary of key findings for parents

This provision is good

- The manager has high expectations of staff and reflects on the setting's practice effectively. She acts on the advice of others, such as other early years professionals, to help improve practice and children's outcomes. For instance, she has successfully raised the quality of practice to good levels following actions set at the last inspection.
- Children are happy and confident. Staff are caring and friendly, and form warm bonds with children. They are sensitive to children's needs and support their emotional wellbeing effectively.
- Partnerships with parents are a particular strength. For instance, staff communicate with parents regularly about children's ongoing development and help them to support children's development at home.
- Staff support children's communication skills very well, such as while using new words for children in context to help extend their language development. Children make good progress and develop the skills needed for their future learning.

It is not yet outstanding because:

- Staff do not plan some areas of the environment effectively to help encourage children's motivation to try a broad range of activities, to enhance their development further.
- At times, staff do not encourage children to use their home languages in their play and learning to aid their development.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- review the organisation of the environment, to enhance children's motivation and enjoyment to explore a broad range of experiences, to help extend their learning experiences further
- build on opportunities for children to use their home languages in the setting to help aid their learning.

Inspection activities

- The inspector observed the interactions between staff and children as they engaged together in activities.
- The inspector and the manager undertook a joint observation of a teaching activity.
- The inspector held discussions with the manager and staff during the inspection about children's care and the activities provided for them.
- The inspector took into account the views of the parents and carers spoken to on the day and engaged with children at appropriate times.
- The inspector viewed documentation during the inspection, such as the setting's policies and procedures, and children's attendance registers.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. The manager understands her responsibility to protect children and implements clear policies and procedures to ensure their welfare. Staff know how to recognise and report any signs that indicate a child may be at risk of harm. The manager reflects on the quality of staff's teaching practice effectively and supports staff well to help provide good outcomes for children. She offers good opportunities for staff to develop their teaching, including through the information they gain from other professionals. The manager and staff communicate effectively with other agencies that work with children to help support consistency in their care and learning experiences.

Quality of teaching, learning and assessment is good

Children are confident and keenly explore activities of their choosing. They enjoy sensory experiences, such as while smelling and cutting vegetables during role play. They learn to talk about the names of different vegetables, learn about size and develop their handmuscle control well. Children concentrate and are focused during activities they engage in. Staff check on children's achievements successfully and know their key children well. They observe children regularly and monitor their progress effectively to help swiftly recognise and address any gaps in their learning. Staff have a good understanding of how children learn and adapt their teaching well overall to support children's individual needs. For example, they use hand gestures while talking to children who may need extra support, to aid their early communication skills.

Personal development, behaviour and welfare are good

Children behave well. Staff successfully share their behavioural expectations with children, such as through reminders, to help children learn how to behave with others. Children learn how to use equipment and how to keep themselves safe. They eat nutritious food, are active and enjoy using equipment. For example, children use equipment outside, including ride-on toys, to help develop their balance and physical skills. They have good opportunities to learn about diversity, such as while engaging in activities that help them to learn about different cultural backgrounds. Children develop their understanding of different people in the community well and develop mutual respect for others.

Outcomes for children are good

All children make good progress from their starting points and develop skills that support their next stages of learning. Older children interact and communicate with others confidently. They learn to write their name and use writing tools with good control. Babies babble happily while they play and toddlers learn to use words during story time. Children develop good mathematical skills, such as counting amounts accurately.
