Summary of key findings for parents

The provision meets requirements

- The childminder has a clear understanding of how to safeguard children's welfare and support their well-being. She plans to work closely with her assistant to help update her policies and procedures to ensure children are kept healthy and safe.
- The childminder understands the importance of working in partnership with parents and plans to obtain information from parents about children's interests and learning needs.
- The childminder understands the importance of liaising with other professionals and the local authority to meet the needs of children and their families.
- The childminder has a good range of resources to help her deliver the educational programmes to different groups of children when they start. She has a sound knowledge of how to use observation to help her assess and plan for children's individual needs.
- The childminder understands the importance of supporting children's emotional well-being. She intends to praise children for their good behaviour and help them learn to respect the similarities and differences of other people who they meet.
- The childminder has an action plan in place to help her continually improve.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at the childminder's policies and procedures, including safeguarding children and the complaints procedure.
- The inspector discussed with the childminder her self-evaluation and how she plans to further improve.
- The inspector discussed with the childminder how she plans to share information with parents and other relevant professionals about children's care, learning and development.
- The inspector looked at the range of toys and resources indoors and outdoors to meet the needs of children.
- The inspector discussed with the childminder how she intends to assess children's abilities and plan for children's individual needs and ongoing progress.

The childminder registered in 1997. She lives in Wimbledon. The childminding service is open from Monday to Friday from 8am to 6pm all year round. The childminder's husband works as her assistant.
