Summary of key findings for parents

The provision meets requirements

- The childminder shows an understanding of her responsibility to keep children safe and protect them from harm. She understands how to recognise and report any concerns.
- The childminder explained the importance of working in partnership with parents to ensure that they feel part of children's ongoing development and to help support children's emotional well-being.
- The childminder describes how she plans activities and routines to support children's learning and help them make progress. She understands how to assess children's development and help prepare them for starting school.
- The childminder knows the importance of evaluating her practice. She understands how to improve the quality of her provision, for example, through training to update her skills and knowledge and through her partnerships with other registered providers.
- The childminder explains how she helps children behave well and value each other.
- The childminder understands how to promote children's well-being. She describes how she provides children with plenty of opportunities for physical exercise.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector observed areas of the home used for childminding, and talked to the childminder about her understanding of the learning and development requirements.
- The inspector viewed the childminder's written policies and some compulsory documentation.
- The inspector discussed with the childminder how she evaluated her practice and how she has updated her skills since registration.
- The inspector discussed the childminder's understanding of the safeguarding and welfare requirements, and the systems to keep children safe.
- The inspector spoke with the childminder about how she would work in partnership with parents and any other professionals involved in children's care.

The childminder registered in 1992. She lives in Greatham, Hampshire. When working, the childminder is available Monday to Friday from 7.30am to 6pm, throughout most of the year. The childminder holds a childcare qualification at level 3.
