## Summary of key findings for parents

#### The provision meets requirements

- The childminder is fully aware of her responsibilities in the event of a safeguarding concern about a child in her care. She is aware of the possible signs and symptoms of harm and neglect and knows the local child protection referral procedures.
- The childminder describes how she will observe and assess children's learning and development. She explains how she will identify their abilities and plan for the next steps in their learning, to help them make continual progress.
- The childminder holds a current paediatric first-aid certificate. She uses professional development opportunities to enhance her knowledge and skills in childcare.
- The childminder understands the importance of working in partnership with parents to support their child and meet their individual needs. The childminder is knowledgeable about building relationships with other early years settings that children attend to promote consistency in children's care and learning.
- The childminder understands the importance of gathering the views of parents and children and using these to help inform her self-evaluation process.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
