Summary of key findings for parents

The provision meets requirements

- The childminder has an up-to-date knowledge of safeguarding legislation and procedures. She knows how to report concerns about children's welfare.
- The childminder understands how to observe and plan for children's learning. She can demonstrate how she assesses children's progress when they first start and between the age of two and three years. She has developed a system of recording children's progress and used this successfully in the past to share information with parents.
- The childminder describes how she extends her professional knowledge further and how this helps her identify areas where she could improve her practice.
- The childminder knows how to develop children's independence and knowledge of colours and numbers to help them to be ready for their next stage in learning, including starting school.
- The childminder recognises the importance of supporting children's good behaviour. She knows to set clear boundaries and use positive reinforcement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and childminder discussed her knowledge of safeguarding, risk assessments and child development.
- The inspector sampled the childminder's policies and procedures.
- The inspector discussed with the childminder how she plans for continual professional development.
- The inspector viewed areas of the home and resources used by children.

The childminder registered in 1992. She lives in the London Borough of Bromley. She provides childcare all day on Tuesday to Thursday for most of the year.
