Summary of key findings for parents

The provision meets requirements

- Safeguarding is effective. Staff have a clear understanding of how to protect children's welfare. They understand how to keep them safe and are aware of the procedures to follow to report any concerns relating to children's safety.
- The manager and staff understand how to reflect on the club's practice and explain recent changes they have made to improve security. For example, they have installed a camera on the main door to help them know when people wish to gain access.
- Staff understand the benefits to children when they work in partnership with schools and other professionals. They know how to be proactive in sharing information with them to help promote continuity in children's development and experiences.
- Parents talk positively about the staff, stating staff help children to be, 'Happy, secure and settled at the club'. Relevant information is shared with parents.
- Staff understand how to plan an exciting range of activities which considers children's interest and wishes.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the manager about her understanding of the requirements of the early years foundation stage.
- The inspector discussed with the manager what resources and equipment they have in place for children to use. She also observed part of the session with the older children.
- The inspector looked at the evidence of the suitability of adults who work on the premises and directors, a selection of policies, safety procedures and required documentation.
- The inspector took into account the reflections on practice, ongoing action plans and the written views of parents.
