## Summary of key findings for parents

## This provision is outstanding

- The management team inspire and motivate all staff to provide an excellent level of care and activities for children. They lead the team effectively and have high expectations in their pursuit for excellence.
- All children excitedly join in a wide range of stimulating games and activities. They demonstrate exceptionally high levels of engagement, motivation and confidence.
- Children have a very strong sense of belonging at the club. For example, they have regular meetings to vote on topics and this gives high importance to their opinions. All staff have very high expectations for children's well-being and care.
- Children behave exceptionally well. Staff are excellent role models. Children follow rules conscientiously and know how to keep themselves safe. They learn to be kind and considerate to others. For example, they take part in fundraising activities for charity and help each other at the club.
- Staff build highly successful links with school teachers. They use information about children's learning to provide fun and stimulating activities, which further builds on their learning. There is highly consistent care and learning for children. Staff also keep parents very well informed about their child's day and time at the club.
- Parents highly praise the staff and the wealth of activities on offer. They comment on the excellent safety and well-being of their children while they are at the club.

# What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

■ continue with the exciting plans to extend children's play outdoors even further.

### **Inspection activities**

- The inspector observed the activities indoors and outdoors, and the interactions between children and staff.
- The inspector talked to children and staff at appropriate times during the inspection.
- The inspector completed a joint observation with the manager.
- The inspector held a meeting with the club manager and owner. She looked at relevant documentation and evidence of the suitability of staff working in the club.
- The inspector spoke to a number of parents during the inspection and took account of their views.

# **Inspection findings**

### Effectiveness of the leadership and management is outstanding

Safeguarding is effective. Managers and staff have an excellent understanding of their responsibility to keep children safe. They know the correct procedures to follow if they have concerns about a child's welfare. Staff are exceptionally vigilant in their supervision of children and ensure the premises are safe and secure. Managers provide highly effective systems for staff supervision. They promote a culture of self-reflection and teamwork. For example, staff share constructive feedback and ideas. They support each other effectively to maintain the highest standards. Managers encourage staff in their professional development and acquiring of further skills through training and coaching. Managers have excellent ideas for improvement and are highly responsive to the views of children, parents and staff. They make changes that have excellent results. For example, they have introduced a wider range of exciting activities tailored to children's different ages and interests. Managers are considering more ways to enhance the popular outdoor area and increase the range of activities even further.

### Quality of teaching, learning and assessment is outstanding

Expert staff skilfully adapt activities for children and all children enjoy playing in mixed-age groups. Staff adeptly build on what children are learning at school through exciting play activities. For example, they extend activities about planting and growing vegetables from school. Staff support children's learning naturally through play. For example, an interest in an upcoming royal event provided opportunities for children to practise their reading, and writing responses to invitations. Staff celebrate and promote diversity in all aspects of practice. They promote an exceptional range of experiences that celebrate differences and similarities. For example, they have high-quality discussions with children about different cultural music, foods and customs. Children show excellent team working and problem-solving skills. For example, they work out how to assemble a kite using various materials.

#### Personal development, behaviour and welfare are outstanding

Children thoroughly enjoy their time at the club they are exceptionally happy, settled and self-confident. Their extremely positive relationships with the staff significantly support their emotional well-being. Children are fully absorbed and engaged in their games. They thrive on the freedom to choose and lead their own play and activities. Children take part in energetic outdoor games and benefit from plenty of exercise and fresh air. Staff help children learn about healthy lifestyles. For example, they enjoy healthy snacks and make links to a healthy eating project they recently completed. Children flourish in the outdoor area running freely, climbing, and playing team games. Staff join in with enthusiasm and provide close support. Children make their own snacks and have animated discussions with their friends and staff. They develop their independence extremely well.
