Summary of key findings for parents

The provision does not meet requirements

- The provider does not understand the requirement to maintain records to demonstrate staff are suitable to carry out their role, such as suitability checks. In addition, not all relevant documentation is available as required, including paediatric first-aid certificates.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Tam's After School registered in 2018. It is located in the Scout Hall in Stoke Newington, within the London Borough of Hackney. The club operates Monday to Friday from 3pm till 6pm, during term time. The provider holds a level 3 early years qualification and employs two members of staff.
