Summary of key findings for parents

The provision meets requirements

- The childminder is very experienced and has a secure knowledge and understanding of the learning and development requirements. She understands how to obtain children's starting points, assess their progress and knows how to help them gain skills for school.
- The childminder completes continuous training to keep her knowledge of safeguarding and child protection up to date. She is able to confidently discuss potential issues that may threaten children's welfare and understands how to report any concerns.
- The childminder understands how to use effective teaching strategies, such as incorporating children's interests in the planning of activities. She explains how she intends to use her wide range of resources to help children learn and develop.
- The childminder understands the importance of developing effective partnerships with parents. She describes how she intends to share information with other professionals where children attend, and with those involved in children's care.
- The childminder explains how she continues to review her practice. She explains how using children's and parents' views assist in identifying strengths and areas to develop.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at documents relating to evidence of suitability of household members.
- The inspector looked at training records and discussed how the knowledge gained will be used to inform the childminder's practice.
- The inspector viewed all areas and resources to be used by children.
- The inspector discussed policies and procedures that the childminder intends to use.

The childminder registered in 1994. She lives in Jacobs Well, near Guildford, Surrey. She operates all year from 7am to 6pm, except for family holidays and public holidays.
