## Summary of key findings for parents

## This provision is good

- Partnerships with parents are strong. Staff encourage all parents to take an active interest in their children's education. Parents share details of children's personal triumphs, such as when they learn to independently use the toilet.
- The manager monitors planning to check that activities are suitably challenging for individual children. Older children focus well and they complete more complex tasks. All children make good progress and they are well equipped for the move to the school.
- Staff help children develop their mathematical knowledge, such as when they encourage them to identify a variety of shapes. Children use their memory skills and they compare shapes in their own environment to similar shapes in the play box.
- Staff give children precise instructions and children enjoy taking part in well-organised musical activities. Children use their listening skills and they copy the sounds they hear. They are animated as they sing familiar songs and develop their speech.
- Staff encourage children to move freely. Children use available space and wriggle across the floor. Children build up physical strength and they jump and cycle around obstacles.

## It is not yet outstanding because:

- Staff do not establish strong links with early years practitioners at other settings that children attend, to share all information about learning.
- Staff do not consistently encourage children to explore the wide range of resources available to them to enrich their creative projects.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- strengthen partnerships with staff at other settings involved in children's care to share all information and raise outcomes
- encourage children to make their own choices about how to develop and enhance their creative projects.

#### **Inspection activities**

- The inspector held conversations with parents. They discussed how staff prepare children for the move to school.
- The inspector and the manager took part in a joint observation activity.
- The inspector talked to staff about the progress children have made since they started at the pre-school.
- The inspector viewed staff supervision records and spoke to the manager about how she plans staff training.
- The inspector discussed safeguarding with staff and the opportunities available to them to refresh their knowledge.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

The experienced manager and her staff team create a welcoming environment for all families. They make improvements that have a positive impact on children's lives. For instance, they identified that as a staff team they could enhance children's dental health. Staff teach children how to keep their teeth in good condition and they encourage them to follow a regular cleaning routine. The manager offers staff a broad and interesting range of training opportunities to advance their teaching skills. For example, recently staff developed their knowledge of how to meet the needs of two-year-olds. Staff use the strategies they learned to help all children express their emotions. Safeguarding is effective. Staff are aware of the important role they play in keeping children safe. They frequently update their safeguarding knowledge. Staff have a secure understanding of how to identify children at risk of harm. They work well with external agencies, such as children's social care, to raise outcomes for children.

#### Quality of teaching, learning and assessment is good

Staff have increased opportunities for children to learn how others live. For example, they read stories about children who live in other communities. Children are thrilled as they experiment and taste fruit that is common in other countries. Staff encourage them to describe the texture of the food they eat. Staff help children to estimate distance and to test out theories. For instance, children adjusted the gradient of a slope and guessed how far their vehicles would travel. They celebrated their achievements when their answer was correct. Staff continually and correctly assess children from the time they start. They set achievable targets for children to help them make continual progress.

### Personal development, behaviour and welfare are good

Staff help children to understand the rules and expectations of the setting. Children consistently display good manners and they are kind to their friends. Staff support children to settle quickly when they arrive in the morning. The nursery is a hive of activity, and children are excited to see their key person and to share news from home. Staff are enthusiastic role models, such as when they model how to spread butter. Children skilfully and carefully move the knife across the bread. Staff teach children how to navigate risks in the environment. For instance, they discuss road safety and children discuss how to safely cross the road when they visit the shops.

#### **Outcomes for children are good**

Children write their names on their work. They identify a range of colours and discuss colours when they notice them in the play area. Children learning English as an additional language attain very well and make similar progress to friends. Children are able to tolerate delay, such as when they wait patiently to use more popular resources.

Bushy Tails Pre-School registered in 1997. It is situated in Waterlooville, Hampshire. The pre-school opens five days a week from 8.30am until 3.15pm, during term time only. There are nine members of staff, eight of whom hold a childcare qualification at level 3. The nursery receives funding for the provision of free early education for children aged two, three and four years.
