### Summary of key findings for parents

#### The provision meets requirements

- The manager demonstrates she has a robust understanding of her roles and responsibilities to safeguard children. She knows the procedures to follow should she have concerns about a child's welfare. She assesses risks in the environment. Recruitment and vetting procedures are robust.
- The manager has a thorough understanding of how to promote positive behaviour strategies with children.
- The manager demonstrates an awareness of the importance of working in partnership with parents and other professionals involved in children's care. She understands the need to share relevant information.
- The manager understands how to support children's health and physical well-being. She knows to provide children with healthy food and regular exercise.
- The manager demonstrates how she regularly seeks the views of parents and children and uses this information to drive ongoing improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector had a tour of the setting and checked the premises and equipment were suitable and safe.
- The inspector discussed childcare practices with the manager.
- The inspector checked relevant documentation, such as evidence of staff's suitability, policies and procedures and the setting's self-evaluation.
