# Summary of key findings for parents

#### This provision requires improvement. It is not yet good because:

- Leaders and managers track the quality of teaching. However they do not always make good use of the information gathered. Consequently, teaching is not consistently good across the nursery.
- There are no arrangements in place for ensuring the detail within the progress check for children aged between two and three years is accurate. As a result some of the written summaries do not provide parents with precise information.

## It has the following strengths

- The key person system is well established, this leads to children settling well and exploring their environment confidently.
- Practitioners make sure that all children, who speak English as an additional language, have daily opportunities to develop their spoken English in readiness for their transition to school.
- Children behave well. They receive consistent messages from practitioners about what is and is not acceptable behaviour. As a result they show respect to each other and learn to take turns.
- Staff offer children freshly prepared nutritious snacks. This helps them learn about healthy eating options.

- The inspector observed the quality of teaching during both indoor and outdoor play activities and assessed the impact this has on children's learning experiences.
- The inspector completed two joint observations of practice with the deputy manager.
- The inspector spoke with children, parents and staff at appropriate times throughout the inspection to gain their views and took these into account.
- The inspector held a meeting with the manager and deputy manager.
- The inspector looked at relevant documentation and evidence of the suitability of staff working in the nursery.

# **Inspection findings**

## Effectiveness of the leadership and management requires improvement

Since the last inspection leaders and managers have not sustained good practice in all areas. They have not monitored the quality of the completed assessment of the progress checks for children aged between two and three years. In addition management have been slow to introduce an effective staff supervision system. Consequently, they have not managed inconsistencies in the quality of teaching swiftly enough. Safeguarding is effective. Staff have attended relevant training and are knowledgeable about local safeguarding procedures to help keep children safe. Parents say that they are happy with the care their children receive. They report that they know their child's key person and have frequent opportunities to meet with them. Children are well supervised because leaders and managers ensure staff are effectively deployed across the nursery.

## Quality of teaching, learning and assessment requires improvement

The quality of teaching is varied. Some staff do not always prepare activities well and do not adapt activities to reflect the different stages of the children participating. For example, they do not engage children during planned activities. Sometimes they fail ensure that the learning intentions such as, comparing sizes are clearly presented. Consequently, children lose interest quickly. Some staff fail to notice the quieter children and do not engage them in activities. However, some staff confidently provide opportunities to challenge children and extend their learning. For example, during a story time children make links between the story and their own experiences. Staff listen and give children time to talk and think. Some staff model learning well. For example, they help children to engage and explore their ideas as they sensitively join in children's play and pretend to enjoy the tea made by the children.

#### Personal development, behaviour and welfare are good

Children develop good social skills. They enjoy eating their snacks at the table together in a relaxed atmosphere. They are supported by friendly staff who encourage the children to serve themselves and clear away their plates when finished. Children listen to each other and take turns. For example, at circle time they wait patiently for their turn to guess the object hidden in the sock. They learn to keep themselves safe particularly during outdoor play. For example, when playing on the ride on bikes and cars they follow rules and travel in one direction to avoid bumping into each other. Parents report that staff teach children to be polite and well mannered.

## **Outcomes for children require improvement**

Based on their starting points all children are steadily developing the characteristics needed for their next stage of learning. Many children are learning English as an additional language and parents report improvement in their children's vocabulary and understanding. However due to the variation in teaching the progress for a few children is not as rapid as it might otherwise be.

The setting is open each weekday from 8.45am to 11.45am, and an afternoon session is offered from 12 noon to 3pm on Tuesday, Wednesday and Thursday, term time only. The nursery provides free early education for children aged two, three and four years. The setting employs 11 staff, nine of whom hold relevant childcare qualifications.
