- The childminder understands the value of developing partnerships with parents and other adults involved in children's lives. She knows how to monitor children's progress and how to keep parents informed about it to maintain consistency.
- The childminder understands the importance of teaching children about healthy lifestyles, such as eating healthily, exercising daily and following good hygiene.
- The childminder knows how to encourage children to behave well and respect others.
