### Information about this children's home

- The home is registered to care for up to three young people.
- This is a privately owned home.
- There has been no registered manager since 30 August 2016.

**Inspection date:** 25 May 2018

## This monitoring visit

On the 24 April 2018, Ofsted completed a full inspection that judged the home inadequate. Ofsted issued a restriction of accommodation notice. The purpose of this monitoring visit was to review compliance with the notice. The other requirements issued at the full inspection were not reviewed as part of this monitoring visit. However, consideration has been given to the progress made in improving the quality of care for young people.

The registered provider has fully complied with the restriction of accommodation notice. No young people have been admitted to the home.

Since the last inspection, two young people have been discharged, with one young person remaining at the home. This has contributed to a significant reduction in safeguarding incidents. The home has been settled since the last inspection.

In response to these discharges and the current restriction of accommodation notice, the staff team has reduced. Two staff have now successfully achieved the relevant required qualification and a third member of staff is due to undertake the qualification.

The acting manager recognises the ongoing need for staff to develop their skills, experience and knowledge to meet the needs of young people. Despite this, the current training available to staff has been identified by the manager to be

insufficient in quality and depth. The manager is currently sourcing additional training.

Managers have taken initial steps to review the shortfalls in the maintenance of the home. This means that managers have a better understanding of the improvement needed to ensure that young people are able to live in a homely and welcoming environment. However, a timescale to address the identified shortfalls has not been finalised.

Managers have taken action to improve fire safety. A revised fire assessment and inspection from the local fire service means that there are no immediate safety concerns. However, an action from the previous and current fire safety assessments remain outstanding. This is specific to the storage of fire extinguishers.

The acting manager is currently in the process of applying to Ofsted to be the registered manager. The acting manager is receiving supervision from a suitably experienced individual. However, this is a recent development and therefore the impact that this has on the care of young people is not yet clear.

A new service manager is in post and is in the process of applying to Ofsted to be the responsible individual. This appointment enhances the leadership of the home. However, the service manager has only been in post for a week and therefore his ability to achieve sustained improvements in the quality of care is yet to be established.

- Any home using monitoring equipment should have a written policy describing how this will support the safeguarding and well-being of those living in the home in accordance with regulation 24. ('Guide to the Children's homes regulations including the quality standards', page 16, paragraph 3.16)
